## FALL CLEANUP REPORT

Neighborhood volunteers did another bang-up job with our fall mini-cleanup held Saturday, October 24, in Gifford Park. Everyone worked hard and had fun. We filled 2 20-cubic-yard dumpsters, hauled trash, placed wood chips around park trees, painted a park swingset, gave away pumpkins, had a picnic for volunteers, salvaged recyclable items like scrap metal and garage sale items, separated tree brush from the dumpsters, collected \$85 in salvage metal, and collected \$150 in GPNA memberships and donations.

The weather was outstanding again and this made for perfect working conditions. I want to share with you some of the highlights of the cleanup. Bob Hutton taught us many tricks on how to load three dumpsters worth of trash into just one. I don't know what we would have done without Ron Yates and his truck, "Old Green" — Ron made countless hauls and took care of our scrap metal collection. His wife Cynde was our designated emergency operator when we needed phone calls made. Mike Caban put together a painting crew, which included CJ Cullinan and John Frazier, to paint a large swingset — it looks like new! Mike's wife Judi and Kathy Rose headed the information and membership table all day in the hot sun. They kept the show going smooth. Great job, ladies! Kathy's husband Tom "The Enforcer" Rose was our "traffic controller" for trucks hauling in and out of the parking lot — not an easy job when you consider many kids playing around the park during the cleanup. John Lynch and his family handled the picnic festivities. John found out that he indeed can roast hotdogs on two grills at the same time. Ed Hendershot as always provided the Halloween pumpkins, tools, phone, truck, and bathroom (we're sure glad Ed lives close to the park). The Wilwerdings were well-represented in the cleanup: Leo made two trips for wood chips to put around park trees, his sons Terry and Jim helped with hauling and loading dumpsters. My wife Sallie gave me timely support and helped behind the scenes to prepare for cleanup day. The GPNA thanks the neighborhood businesses for their generosity: Loren Johnson (J'N'J Grocery) provided 200 hotdogs, Wayne and Peg Hill (California Bar) contributed five cases of pop along with ice and a cooler, and 7-Eleven provided coffee and cups for volunteers. Other organizations helping out were: The City of Omaha Park Maintenance and Forestry Division (they took care of our tree brush), House Arrest (Lt. Stangel), and K.O.B. (Keep Omaha Beautiful).

I want to give special recognition to three individuals who contributed to our cleanup effort in big ways. Paul Newell kept the parking lot swept and helped load dumpsters. Charles Cunningham spread wood chips around park trees and helped load dumpsters. John Gossett spent much of the day smashing furniture to save dumpsters space for us — this is a difficult job requiring strength and safety and few people could have broken up as much furniture as he did that day. But what impressed me most about these three guys was the fact that they don't even live in this neighborhood. There were other volunteers I wish I could recognize, but I better not make this article too long.

These neighborhood cleanups bring out so much in the people involved. It's hard work, but it also gives you a good feeling of pride to work together as a team to make things more attractive where we live. Our next neighborhood cleanup is in the spring (April). The GPNA invites everyone to participate, because the difference starts in your own neighborhood.

## OMAHA COMMUNITY PARTNERSHIP

The Omaha Community Partnership has been created, whose mission is "To have a safe community in which all citizens share the responsibility for zero tolerance of the illegal use of tobacco, alcohol, and other drugs through a spirit of cooperation and coordination of services." 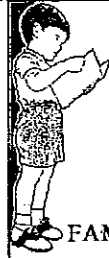

## HOLIDAY DECORATING CONTEST EXPANDED THIS YEAR

**ANOTHER GROUP HOME?!***a commentary by Mike Caban*

On the evening of October 6, a delegation representing the GPNA, Yates School, Yates PTA, OPS, Creighton University, Creighton students, and St. Joe's Hospital, met with representatives of St. Leo's Church, on 102nd and Blondo. Our common concerns were expressed eloquently by several in our group, regarding the location of a shelter for men across the street from Yates Elementary School, at 3126 Chicago.

St. Leo's representative elaborated on the merits of the project, their criteria for choosing this site, and listed supporters of the program. There was no immediate indication that our concerns had an impact on their decision.

What St. Leo's Parish doesn't fully appreciate is the position our community is in. On the surface it may appear as if we are overly sensitive to this one specific program. That's not the issue at all. When comparing the Gifford Park neighborhood with other areas of Omaha, including St. Leo's Parish, we have more than our share of group homes already.

Over thirty five percent of the property in this area is occupied by group homes, halfway houses, and other forms of subsidized housing. It seems to me that older inner-city neighborhoods like Gifford Park are targeted as fertile ground for these programs, when what we need is stable family influx.

Meanwhile, millions of dollars in block grants, community centers, libraries, new schools, and community renovation projects flow into both the suburbs and high crime areas of Omaha, and seem to miss areas like ours year after year.

The people in this neighborhood deserve better. We have worked hard to discourage crime in our streets, and to maintain a sense of community under difficult circumstances over the past several years. We're proud of the success we've had so far, and are fully aware of the work that remains ahead of us.

If we seem a bit sensitive to the health and safety of our neighbors, and our children, forgive us, but when no one else gives a damn, you learn to do for yourself. And we have. I don't know of a neighborhood that works as hard to keep its head above water.

Maybe that's why we have misgivings when those who can't relate to our situation, unload their good intentions into our back yard. Supporters of this program should know that a group home for men, located so close to a school, is totally unacceptable. Here, or anywhere.
