### Fall Cleanup To Be Held October 19

This year's annual GPNA Fall Cleanup is scheduled for Saturday, October 19, from 9 a.m. to 2 p.m. in Gifford Park. The fall cleanup is for GPNA MEMBERS ONLY, or people who donate their time or money to the cleanup. There will be dumpsters and a compactor for hauling trash, a membership and donation drive, scrap metal recycling, a Halloween pumpkin patch, police/safety information, Project Impact representatives, and hot dogs for the helpers. Volunteers are needed to provide pickup trucks for hauling, assist in packing and monitoring dumpsters, and help in making pickups. The cleanup day is a great time for everyone in the neighborhood to take a look around their yards and streets and pick up trash and other debris - especially before the winter sets in. The net effect is a nicer looking neighborhood - one that we can all be proud of.

PLEASE NOTE: It is very important for you to call the phone numbers listed below <u>BEFORE</u> the day of the cleanup if you are unable to bring your trash to the park yourself and need a volunteer to help - we will prioritize hauling based on your call. The following items <u>WILL NOT</u> be accepted: tree brush and appliances containing refrigerant (freon) - save them for the spring cleanup. Tires <u>WILL</u> be taken at the fall cleanup this year for \$1.00 apiece. A \$5.00 fee will be charged for sofas and overstuffed chairs. # Midtown Community Reinvestment Study Update

In August we reported on a movement to do a master plan study of the midtown area including the Gifford Park neighborhood. Since July, a steering committee has met about five times to look into the feasibility of commissioning a master plan study. The steering committee has representation from Mutual of Omaha. Creighton University, Kiewit Construction, UNMC. NHS, OPPD, Omaha Chamber of Commerce, All Makes Office Equipment, Mayor's Office, City Planning Department, City Council, Med-Center Merchants, Leavenworth Neighborhood Association, Joslyn Castle Neighborhood Association, and the Gifford Park Neighborhood Association. The targeted area is Saddle Creek Road on the west, Cuming St.on the north, about 20th St.on the east, and Center St. on the south.

Our last meeting was September 18 in which we further defined the scope of project and made some key decisions. All the meetings have been very productive and everyone on the steering committee is committed to improving the area both short-term and long-term. In addition, the neighborhood associations have met separately to define goals and priorities so we can focus on issues important to the neighborhoods. Down the road there will be opportunities for many of you to be involved with the master planning process. The commitment and involvement of the neighborhood associations is critical to the long-term success of developing a master plan and implementation of the plan when completed. ### **Tow Lot Cited For Zoning Violation**

On Monday, September 23, the City Administration Board of Appeals told the owner of the tow lot (just west of 33<sup>rd</sup> & California) that they had 5 days to remove all vehicles from the property. The tow lot owner was appealing the case (notice from police to remove dead storage, unlicensed vehicles). The property is zoned R7 (residential) and so the tow lot business is in violation. The GPNA and other concerned neighbors sent letters in opposition to the tow lot operation. Because of the zoning, this operation should never have been allowed to locate there in the first place.
