## Ron And Vicki Frey Named 2005 GPNA Neighbors Of The Year

The husband and wife “team” of **Ron and Vicki Frey** are two people who definitely deserve to be honored as the 2005 GPNA Neighbors of the Year for all of their hard work and dedication to the Gifford Park neighborhood. They have served the GPNA in a variety of capacities since shortly after moving into the neighborhood. Their efforts have truly furthered the cause of making the Gifford Park area a better place to live, work, and play.

The Freys moved to the neighborhood in September of 1995 on the recommendation of **Ben and Dar Sweazy**. They purchased a “fixer-upper” at 3555 California St., and spent the first few years here working on their house. During this time, they discovered a love for older things when it came to remodeling, and they tried to keep their home “period correct”. By the late 1990’s, they began to attend GPNA meetings and started helping with the Association’s various activities. In 2000, they made a conscious decision to “get to know the neighbors” by becoming more involved with the GPNA. When she heard that there was no candidate for the Secretary’s position, Vicki volunteered and was elected to serve from 2000-2002, and Ron took over the position the next year.

In 2003, Ron became President and served until 2005 and Vicki was the Treasurer during this same time period. During his presidency, Ron decided to focus on the benefits of living in the Gifford Park area. He became

## Gifford Park Neighborhood Association Housing Code Re-scan And Follow-up Survey

### Preliminary Findings

The Gifford Park Neighborhood Association scanned 344 properties in June and July of 2005. The first scan identified 212 properties (61.6%) with 1 or more violations. Two separate mailings were sent out to those with 1 or more major violations. One mailing was sent to the 19 properties with 4 or more major violations and a separate mailing was sent to the 90 properties which had 1, 2 or 3 major violations. The remainder of the scanned area received an informational letter about the condition of the scanned area. In December, these properties were re-scanned to assess what corrections had been made since the initial scan. There were 531 problems found with properties in the Gifford Park Neighborhood. During the August 2005 re-scan of these properties it was found that:

- 214 problems had been fixed (40.3%)

Of the 212 properties that were re-rated:

- 35 properties (16.5%) fixed every problem identified in the May 2005 scan
- 79 properties (37.3%) had fixed one or more of the problems found in the May 2005 study
- 98 properties (46.2%) had not fixed any of the problems found in the May 2005 study

### Follow-up Survey Findings

A letter was sent to Gifford Park Neighborhood Association residents in September 2005 about a housing scan that was conducted on their block between June 18 to July 12, rating each property on 24 different environmental and housing factors. A total of 344 units in the southwest section of the Gifford Park Neighborhood were scanned by seven volunteer residents and UNO personnel. Each unit was assessed for general conditions, such as weeds and site conditions, as well as specifics, such as the condition of sidewalks, roof, guttering, railings on steps, etc. This confidential survey was designed to gauge residents' feelings about the letter sent to them. Residents were asked to return the survey in the enclosed postage-paid envelope by Nov. 7, 2005. As of Nov. 16, 61 surveys were returned to Omaha Neighborhood Scan.

1. 95.0 percent of those surveyed responded that they remembered receiving the scan letter from Omaha Neighborhood Scan and the Gifford Park Neighborhood Association.
2. 96.6 percent of those who remembered responded that they read the letter.
3. 17.2 percent of those surveyed responded that they used either the Gifford Park Neighborhood Association or Omaha Neighborhood Scan Web site to access information about their property.
4. 84.3 percent of those surveyed responded that the letter received was either very informative (13.7%) or informative (70.6%).
5. 23.5 percent of those surveyed responded that they have made repairs or addressed maintenance items on their property since receiving the scan letter.

### A New Year In Gifford Park

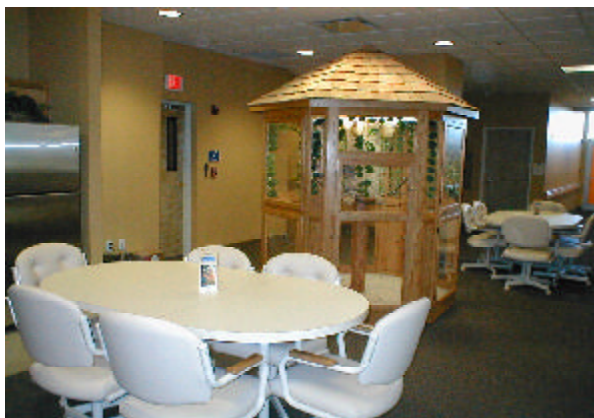

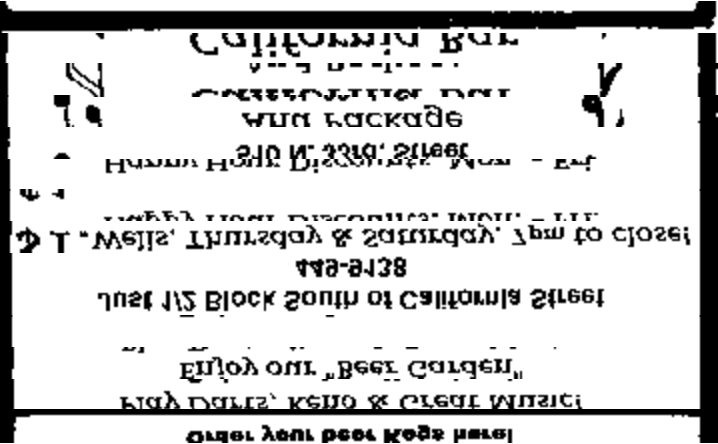

involved with the Main Street Program as a way to revive the small town business district atmosphere. His interest in the Destination Midtown organization lead him to strengthen partnerships between the GPNA and surrounding businesses. ## Snow Removal Rules

A **Snow Emergency** means that no vehicles may be parked on the streets where you see an Emergency Snow Route sign. Crews will plow these streets first. If cars are left parked on an Emergency Snow Route during a snow emergency, the cars will be subject to a fine and may be towed at the owner's expense. Radio and TV stations will broadcast all necessary information.

Omaha's Municipal Code requires **all sidewalks to be shoveled within 24 hours after a snowstorm**. Walks left unshoveled may be cleared by City crews at the expense of the property owner.
