LB 605 - Empowering Neighborhoods

On Monday, February 23, **State Senator Gwen Howard**, many midtown neighborhood associations, Project Extra Mile, and other supporters testified at the state capitol in Lincoln on a new bill, LB 605, introduced by Senator Howard. From the GPNA, **Bob Hutton, Martin Janousek, Darryl Hutton and Chris Foster** testified before the committee. Several others wrote letters of support. We appreciate everyone's efforts, past and present, to stand up for our neighborhood. Below is the Alcohol Impact Coalition's "Statement of Intent" for LB 605:

LB 605 would allow for additional weight to be given to support or opposition of businesses, residents and neighborhood associations within 100 feet of a liquor license application. The Liquor Control Commission may use this opposition as the sole reason for denial of a license. Implements aspects of Nebraska Supreme Court decision in Orchard Hill Neighborhood Association v. Orchard Hill Mercantile and Nebraska Liquor Control Commission, 274 Neb. 154 (2007).

Citizen's Guide To Liquor Licensing

My name is **Margie Magnuson** and I am the spokesperson for the **Alcohol Impact Coalition (AIC)**. Our coalition currently has twelve associations (including GPNA) who are interested in developing a strategy that will minimize the impact of alcohol density, abuse, crime and negative impact in our neighborhoods, establish accountability in the licensing of alcohol outlets and address problem business who sell alcohol. The coalition does not want to discourage economic development in our neighborhoods or to rid our community of all alcohol outlets but a cry to our city and state officials to take into account how many outlets we already have and what additional outlets do to a struggling neighborhood.

AIC wants to make you aware of a booklet we have put together to help residents and neighborhood associations learn more about the liquor licensing and renewal process. We have recently published a Citizen's Guide to Liquor Licensing. This guide is designed to educate residents and neighborhood association leaders on the licensing process here in Omaha. The guide lays out step by step instructions from the basic first step on how to get notified about new licenses coming into your area to the final step of testifying at the Nebraska Liquor Control Commission in Lincoln. This guide is available on line at the AIC website at www.unomaha.edu/ncenter/alcoholimpact.php under the AIC Resource link or there are hard copies that are available at the Neighborhood Center, located at 115 So. 49th Ave.

In December 2000 I had the honor of recognizing Eva as the GPNA "Neighbor of the Year". Below is an excerpt from the January 2001 newsletter highlighting her outstanding volunteer efforts up to that point (she has stayed very active since):

"This year's 'Neighbor of the Year' award went to our historian, Eva Swanson. Eva was recognized for her tremendous work uncovering all kinds of interesting people, places and stories right here in the Gifford Park neighborhood. Many people have enjoyed reading Eva's articles in our neighborhood newsletter for years. This fall she produced a wonderful book called 'History of 33rd & California and History of the GPNA', which are now available for a very good price. Besides keeping our neighborhood's history alive, Eva has made many other contributions to the GPNA including cleanups, Easter egg hunts, Halloween haunted houses, newsletter, garage sales, neighborhood walks, picking up litter, and attending nearly every GPNA monthly meeting. She was recently featured in the Omaha World Herald for presenting historical details about our neighborhood to a Neighborhood Builder's tour on Ollie the Trolley. Eva's parents Elmer and Elsa moved into the house where Eva currently lives in 1923 – the day they were married. In 1991, a former neighbor Rose Blumkin donated \$100 to the GPNA in honor of Elmer (who turned 100 years old) and his daughter Eva. We are grateful that the Swanson's chose the Gifford Park neighborhood to live in many years ago."

Eva, you are a great ambassador for the Gifford Park neighborhood, we will miss you, but we look forward to seeing you at upcoming GPNA events and activities. Good luck in your new place!

Green Homes: Lean And Green

I may not be an economist, but in times like these, it doesn't take an economist to know everyone is trying to pinch pennies, whether you've lost a job or are worried about paying the bills. Often times being Green can also mean being lean—on the planet and on your wallet.

Here are 10 tips under \$10 to help your family live a more eco-friendly, recession-proof life:

1. **Skip that “Going Out of Business” sale.** First know what you really need vs. what you just want. There usually are not good deals on things you *think* you want. And the things you really need, usually have been already sold (and not at a very good price—since liquidators mark merchandise up before they liquidate).
2. **Change a few light bulbs.** I'm serious about this one, if you haven't added any CFLs (those curly bulbs) to your most frequently used light fixtures, give them a try. The new CFLs have great light output, a variety of light colors (from soft white to daylight), and will save you money on your electric bill.
3. **Wear layers—like sweaters.** Turn your thermostat down 1°-2°F to save on your heating bill. During the cold months layer your clothes, even indoors. Most people will be comfortable with a sweater or sweatshirt at 68°F—also known as “sweater temperature”. At night, when you are in bed you can turn the thermostat down to 60°F—known as “blanket temperature”.
4. **Plant a Garden.** As Omaha's last frost approaches (April 15), it's never too early to start planning a garden. Plant veggies regularly used in your family's diet to ensure you eat what you grow. Seed packets cost very little and will save you big on grocery shopping throughout the summer and into the fall harvest. Some easy vegetables to grow in our climate are tomatoes, zucchini, squash, peppers, carrots, and potatoes.
5. **Turn the water heater down to 120°.** You don't need to waste energy by keeping water heater temperatures so hot. Super hot water is just diluted by cold water anyway—thus wasting your money. For natural gas water heaters, 120° is typically between “MED” and “LOW”. Electric water heaters often have temperature listed on the dial.
6. **Turn off unused lights.** I wouldn't normally say this, but I'm surprised how many people have lights on throughout their home in rooms they aren't even in. It just makes sense to not leave lights on that you don't need. Many children turn this into a game if you get them involved. They try to keep all the lights off in rooms no one is in.
7. **Make 2 days a week meat-free.** Meat is a costly item on grocery lists. By fixing healthy, filling vegetarian meals one or two days a week, you can reduce the amount of meat you buy from the store, saving money and reducing the large impact the meat industry has on our environment.
8. **Use a reusable water bottle instead of buying bottled water.** Bottled water can cost as much as \$0.75/gallon. Tap water costs less than ½ of 1 penny per gallon. A reusable water bottle not only saves you over 750% on the cost of water, it also eliminates the large waste stream of plastic bottles going into our landfill.

Bike Event Coming This Spring

Artists, welders, mentors, and business owners should get in gear for **Omaha Metro's Bike Blast**. Local artists, educators, and bicycle buffs are collaborating on the three-pronged project to encourage physical activity, promote public art, and make the community both greener and more beautiful. **Part One: Paint-a-Bike Project** will team two neighborhood groups of children with artists. They will prep, design, and paint a donated bike over the course of three Saturday workshops. The fourth workshop will cover bike safety. Workshops will be held in Midtown Omaha at **First Central Congregational Church (421 South 36th Street) April 4, 11, & 18** and in South Omaha at **Bancroft Street Market (2702 South 10th Street) March 22 and April 4 & 11**. The kids will officially earn their “new” bikes after riding in South Omaha's **Cinco de Mayo Parade on Saturday, May 2**. **Part Two: Design-a-Bike-Rack Project** encourages artists to submit a concept design to embellish a bike rack that will be exhibited before installation at sponsored locations throughout the city. **Part Three: Park It—Bike Rack Sponsorships** asks businesses make a **financial contribution in exchange for a custom bike rack for their customers to use.** [Go to www.unomaha.edu/bikeblast](http://www.unomaha.edu/bikeblast) to see how you can get involved.

Legislative Update



I want to thank all of the neighborhood leaders who took the time to write letters and take their own time off work to come down to Lincoln to testify before the General Affairs Committee in support of my bill, LB 605. It was so impressive to see so many people come to the Legislature because they care about their communities. I appreciate the willingness of everyone to sit and wait for two hours for the hearing to start. I believe we made a positive impression on my colleagues about how important this issue is to us.

LB 605 would give residents and neighborhoods a louder voice in determining whether a liquor license is granted. When a license is poorly managed, they become a magnet for crimes, not only at the licensed establishment, but also in the surrounding neighborhood. Residents have had enough of this crime and simply want to be heard by their government.

The bill would also require an applicant to prove that they are current with all of their federal, state and local taxes. I cannot see how it is fair to all of us that pay our taxes on time that someone who does not pay their taxes can get a license from the State of Nebraska. It is beyond me how anyone can defend the right of any applicant not to pay taxes they owe.

The General Affairs Committee will now discuss the bill. It is my hope that they will look favorably on the neighborhood concerns.

9. **Drive less and car pool.** Even with gas prices lower than last summer, any time you can combine trips or car pool (www.metrorideshare.org) it will save you on your fuel bill. Driving less also reduces the amount of air pollution and greenhouse gases released into the air.
10. **Turn off the TV or computer and go for a walk.** Shutting off your electronic equipment will reduce your electric bill. Getting outside for a walk will get your blood flowing, can clear your mind, and can help you enjoy the world that sustains us with everything from clean air and water to all the natural resources we use in our homes and lives.

Everyone is welcome! AARP representatives will provide free tax help for our neighborhood for the 15th year in a row. Processing of basic tax returns and electronic filing will be available. No appointment is necessary; individuals will be helped on a first come, first serve basis. Please call **Jackie** at **551-3629** for more information. To be able to provide assistance, persons will need to bring the following:

1. Valid Picture I.D.
2. Copies of ALL W-2, 1098, 1099 Forms and the amount of other income received by you and your spouse
3. Tax Identification Number (example: Social Security Number, Individual Tax Identification Number) for you, your spouse and any others shown on the tax return.
4. Provider's address and Tax Identification Number for Child/Dependent Care Credit
5. Form 8332 or copy of divorce decree for non-custodial parent claiming child
6. Proof of Account Number and Routing Transit Number of the financial institution for direct deposit into a savings or checking account.
7. Copy of prior year's tax return, if available.

In My Opinion . . . Empty Storefronts And Neighborhood Associations

It might be pointed out that certain businesses (chiefly those that sell liquor, and are open late in the night) are attractive nuisances, serving as gathering places for people who often cause any number of problems for neighborhoods. As those same people often congregate during the day and evening hours, they serve as a deterrent to other, more responsible people, who often support responsible businesses and contribute their time and effort to neighborhoods to work towards a better quality of life. By allowing such troublesome businesses to operate, the City Council is effectively making the district unsuitable for other, more valuable businesses that would provide services and jobs to neighborhood residents. Certainly we have seen the difficulty of attracting new business to the 33rd and California area due to troublemakers congregating at the store and convenience mart. It is a simple fact of life that, with many options and choices for shopping and dining, good people will avoid areas where there are troublemakers, and will not patronize businesses in those areas.

It should be the responsibility of the City Council to assess the compatibility of proposed businesses with the conditions and goals of neighborhood improvement, rather than rubber-stamping any businesses, under the belief that any business is better than no business. It should be the responsibility of the City Council to recognize businesses that have historically caused problems or been a locus of problems, and deny permission for such businesses to operate in areas where their existence will contribute to neighborhood deterioration. We are asking for the City Council to accept that responsibility.

It should be recognized that neighborhood associations are not the sole arbiters of what works and what does not. But what we observe every day, coupled with police records and reports, must carry some weight in the decision process. Clearly, businesses that derive the majority of their revenue from the sale of alcohol create problems for neighbors and businesses in the area. Allowing such businesses will create more empty storefronts as other businesses are driven out. Such businesses also make it much harder to revitalize marginal residential areas. It is difficult to see where allowing such businesses to move in is to the benefit of the city in general. Certainly it is not a benefit to the neighborhood.

Plot priority will be given first to returning gardeners who have turned in all documentation and monies by April 15, followed by waitlisted gardeners who meet the same requirements. Gardeners will then be notified of their plot assignment. We will **Kick-Off** the 2009 growing season on **Saturday, May 9**, and begin the **Youth Garden Saturday, May 23**. Looking forward to another successful season!

LB 605 would terminate immediately any license upon the sale of the premises holding a license. The purchaser of the premises would be required to apply and obtain a new license in the purchaser's own name before selling alcohol. This would prohibit the use of Temporary Agency Agreements currently used by the Liquor Control Commission.

LB 605 prohibits the storage of alcohol in any retail business that does not hold a liquor license.

LB 605 requires applicants for a liquor license to show documentation that all federal, state, local and Workmen's Compensation taxes are current when applying for license.
