## A Recycling Opportunity In The Neighborhood

Every weekend I see the home owners of Omaha put bags of yard waste on the curb to be taken away. It is my hope that the home owners of Gifford Park will donate that waste to me at **Sweet Thyme Farm** (located directly southeast of the Shelterbelt Theatre). I would love to recycle this waste back into my soil. Many common yard weeds and trees accumulate valuable nutrients in their leaves and can be composted to build soil or used as mulch in the garden and around perennials. Mulch also suppresses weeds and prevents the soil from drying out, which means less work for me. If you have no use for this yard waste, then consider donating it to me. Sweet Thyme Farm can serve as the neighborhood yard waste recycling center. You are welcome to drop it off at the farm; leave it at the gate at 32nd & California at the end of the drive directly east of the Shelterbelt (no plastic bags, please), or e-mail me at [sweetthymefarm@gmail.com](mailto:sweetthymefarm@gmail.com) and I may be able to pick it up with my bike and trailer. As the saying goes: one man's trash is another man's treasure.

**Gifford Park Neighborhood Association** and **Midtown Neighborhood Alliance** received tentative approval to participate in the **Trees Omaha Initiative** (a grant program funded by the **Nebraska Environmental Trust** and coordinated by the **Nebraska Statewide Arboretum** with assistance from **Jack Phillips**.)

### In My Opinion . . .

*Editor's Note: The following article appeared in the editorial section of the Omaha World-Herald this summer.*

On July 21<sup>st</sup>, the Omaha City Council voted to approve a liquor license to Midtown Gas, located at 1349 Park Avenue. According to the city's liquor rules, "The Council shall not grant any new license of any type or permit the transfer of an existing license to a location which is located within 300 feet of a city park." This business is 170 feet from Hanscom Park, well within the 300 foot rule. Because the city liquor rules would deny this permit, the council voted to suspend its rules, then voted to approve this liquor application and then had to vote the rules back in place.

The city council is allowed by law to suspend its rules, but we question if the council acted in the best interest of the residents of this community. The city also ignored state statute 53-177 that does not allow a liquor license within 150 feet of a home for elderly and indigent. Park North Tower, public housing for the elderly, is within 150 feet of this store. This blatant act of approving this license ignores the rules and statutes put in place to protect our neighborhoods. It could be argued that given the location of this new application and the nature of the neighborhood, these rules should be more firmly adhered to.

Like many of the neighborhoods in the eastern part of Omaha, the Ford Birth Site neighborhood association has been working diligently to improve their community for their residents and attract positive business growth. Having an off sale liquor business this close to a park and home for the elderly just creates additional problems, as statistics prove this type of business causes increased crime, public intoxication, panhandling and litter. One outcome is that the children, parents and elderly residents will be afraid to be in the park, staying away from the very place we set aside for them.

The council is approving liquor licenses as a means of business development for struggling neighborhoods that clearly need other services than just more alcohol. The actions of the city council clearly show that the liquor licensing process is an arbitrary system set up to serve the best interests of the businesses and not what it was mandated to do: to protect the health and safety of the residents and our community. If city officials can ignore their own rules what does that say to the residents they serve? It says we can put no faith in the system, that rules are enforced at the whim of the people in power and that the industry with the biggest wallet wins.

There are changes that need to be made with the liquor licensing system locally and statewide. We cannot continue approving licenses just because one was handed out yesterday, and you certainly cannot approve licenses by ignoring city and state rules just to give the new owner a chance to make money.

The Alcohol Impact Coalition calls on the city and state to take a hard look at how they have been conducting business and remember they were put in power to serve and protect our neighborhoods and communities not just our businesses. Here are a few things that need to be addressed: residents need to be notified of city hearings for any liquor application in their area; residents' concerns must be given equal weight to businesses' concerns; that violations like sales to minors, serving intoxicated people or death/injury due to poor business practices must be taken seriously by city and state officials; that bad business owners or businesses who have been denied a license must be red flagged for a re-hearing and not automatically renewed each year; new applicants cannot sell liquor until the state grants a license; and no business can store alcohol at a location that does not have a current liquor license. Some of these ideas will be debated this fall when Senator Gwen Howard's bill, LB 605, comes back for discussion, but some of the other suggestions can be addressed locally by our city council if they are willing to make the changes. Perhaps is it time for the citizens of this city and state to insist on those changes and hold our officials accountable to upholding our current rules and laws.

We are not against banning all alcohol but have been focusing on businesses like convenience stores that do off sale and bad businesses with violations that can negatively impact neighborhoods.*

# Welcome, Students!

We have a large number of university students living in the area who have returned for another year of school. The Gifford Park Neighborhood Association has been working very hard with the city and police to improve the appearance and safety of our neighborhood. The goal of the GPNA is to improve the neighborhood and make it a better place for **all** residents, and we would ask our new student neighbors to become a part of this effort.

The largest part of being a good neighbor is consideration for others. First we ask students to be considerate in terms of noise, especially after 10 PM. Many families in our neighborhood have children or go to work early. Parties are another problem. Unfortunately, parties always seem to end up bigger and noisier than first planned, and the police have been more active in enforcing noise and underage drinking ordinances. Another difficult problem is parking. Our neighborhood has barely enough parking (like school), so you may not always be able to park directly in front of your residence. Please do not park on lawns, across sidewalks, or on the wrong side of the street (facing traffic). Besides making the neighborhood look bad, all of these are parking violations and are subject to ticketing. Also, please do not litter and help us to keep our neighborhood picked up. Many of us pick up trash that we did not leave and we ask that you would help us by doing the same.

Finally, consider coming to our monthly neighborhood meetings and perhaps joining our Association. A \$10 yearly membership will get this newsletter delivered to you every month, and you will meet your neighbors and many other wonderful people during our activities such as neighborhood cleanups and holiday events. We welcome students for the upcoming year, and we hope that you will help us continue to make the Gifford Park neighborhood a better place to live.

# SNAP! Presents . . .

**Speech & Debate**, by Stephen Karam, is a savvy comedy that bristles with vitality, wicked humor, terrific dialogue and a direct pipeline into the zeitgeist of contemporary youth. The story centers around three teenage misfits in Salem, Oregon who discover they are linked by a sex scandal that's rocked their town.
