The Neighborhood Gets a Stage

The Omaha area has plenty of arenas and a wonderful Holland Performing Arts Center but nothing can compare to our new outdoor stage at the Gifford Park Neighborhood Market. The market takes place Friday nights on the empty lot between the California Bar and the K-n-J Grocery Store on 33rd Street in the business district from 5:00pm to 8:00pm.

For many years, our Friday night entertainment at the Gifford Park Neighborhood Market had to navigate a spot between the vendor stalls, either on the gravel lot or in the grassy area towards the back of the market. If it had rained the night before, finding a dry spot for the musicians became difficult.

Last year Eliza Perry, a GPNA Board Member, along with Matt Cronin a GPNA Volunteer, saw the need for a stage. Something that would give the musicians cover from the elements and elevate them visually for the audience without losing the coziness that the market is known for. Eliza and Matt, both big supporters of our local musicians, had a conversation with Cynthia Shuck, our neighborhood Midtown Neighborhood Alliance (MNA) Representative, at the time about applying for the annual MNA Grant. With Cynthia's encouraged, they applied for the grant and months later received notice that they got the MNA Grant. The grant covered the cost of the stage, signage, and lighting. Working with FJC Builders, the stage was completed this spring in time for the opening night of the Gifford Park Neighborhood Market. It's been a wonderful addition to the Gifford Park community and the Friday night market.

Where a neighborhood theatre once stood, one could say we came *full circle* and entertainment has returned to the lot where once stood the *Circle Theatre*. Thank you Eliza, Matt, Francisco – FJC Builders, MNA, and the Gifford Park Neighborhood Association.

The Trial of the Century -- Remembering About the Future 2017

We are seemingly in a Court of Law, at the Federal Courthouse building... or, are we? Let us listen in...

Attorney: "Every good closing argument shall start with 'Ladies and Gentlemen of the Jury' so let me also start that way.

'Ladies and Gentlemen of the Jury,
We are here in this distinguished court of law of the United States District Court, District of Nebraska, and as you heard me say it several times before, I've been speaking to you during the last six month of this long trial representing all the children of Gifford Park Neighborhood who were born starting earlier--by up to five years--than twenty years ago—, in 2017, and ever since.

Ah, we can't really start the same way because we don't have a real jury to speak of. We don't have a jury because we don't have an actual case in a court of law. We don't have an actual case in a court of law because the children whom I represent in front of this court of public opinion don't have standing in front of a real court within the justice system of the United States. The children whom I represent, all too many of whom are now adults, don't have standing in a court of law, and hence we couldn't really bring a law suit. You see, Ladies and Gentlemen of the Jury, to have standing a group or class of plaintiffs need to show three things.

First, they need to have suffered an actual injury in fact, which means that something wrong has happened to them in real life.

Second, they need causation, which means that the particularized something wrong that has happened to them was the direct result of the behavior of the defendant--or defendants--who is, or are, being sued. In other words the group of children who I represent need to show that this behavior that the defendants had caused the children the injury in fact, the something wrong that I just mentioned, that has happened to them.

And third, they need to show something called

redressability. This means just that a court can decide to give the plaintiffs something that would somehow make them whole and would thus make the injury suffered 'be paid for' or so to say to go away.

Without these three things I just mentioned--namely injury in fact, causation, and redressability, no court in this great country would listen to our case at all, so this closing argument you're hearing right now would only happen in our collective neighborhood dreams, as we are imagining a court of public opinion.

We have to do this because for the children whom I represented in front of you during this long lasting trial the injuries in fact that I showed you during the last six months didn't actually happen. The witnesses I brought in front of you whom you've heard speak to you and who showed you all the pictures of the hundreds of broken knees and scratches that the children incurred playing soccer during the last twenty and more years didn't actually come in front of you, because they haven't actually seen any knee injuries. Furthermore, the children never broke any arm playing tennis and none of all the showing of fights and friendships resulting from those childish fights among the youth that the witnesses spoke about ever happened. It was all for pretend. Remember, the medals that some of the children when on to get at national and international competitions? Particularly, do you remember the lady who spoke about her daughter, Maria Duarte, the reputed international tennis player who just returned last year, in 2036, from the global Olympics in Mumbai, India, with the golden medal for US ladies tennis that she brought to Gifford Park?

Or, do you remember the gentleman, single dad, whose spouse had died at birth, but who spoke to you about how proud he was of their son, Alberto Riveira, of here in Omaha from Gifford Park neighborhood, who had been selected for the US national soccer team competing in the world cup at soccer for next year in 2038 to be held in Belgium?

You heard the older gentleman who flew in from Los Angeles California and who mentioned how impressed he was twenty years ago when he visited Omaha and he picked the Gifford Park neighborhood tour when he came for the Neighborhood USA annual conference

that Omaha hosted in 2017. You would remember his words about how he decided after that visit to bring about community gardens in his native town in California, and how he mentioned that in the last fifteen years the initiative took a life of its own and so many other California towns started community gardens that the movement became a strong national trend.

You all were very impressed by our witness, the lady and gentleman who spoke one after the other, who were nearly crying when they showed you the pictures from last years Nobel Prize in economics celebration at the Royal Swedish Academy of Sciences where their daughter Sithúkathiⁿ Míⁿzhiⁿga, Barefoot Girl, born here in Omaha in Gifford Park neighborhood, won the prize for her work on the application of constructal law of flows to economics and assessing the expanded role of the rise of the global network of community gardens in reducing food shortages among the global population, and she was the youngest lady winner of the prize in the history of the prize since its inception in 1968, almost seventy years ago.

Ladies and gentlemen of the jury,

You all heard Mohamed, the bicycle trainer, who as he pointed out twenty years ago used to be a teenager and young leader in the community here in Gifford Park, who spoke about his trainee who was not available to come to this trial because he is currently biking in the renowned global biking competition Tour de France for the third time in his life, and that in the first two times he won the third and the second prize.

You also heard from Mr. Andrew French--the youngest chef who is known globally—reputed on every TV set and tablet and connected phone in the world for his fresh from farm dishes—a modern Gordon Ramsey, I am certain you may remember him from his TV shows back in the years 2015 or so, of the so now well known urban farm to fork movement.

I am sorry to disappoint you right now, after all these great testimonies of witnesses. As I just said, we aren't really in an actual court of law, as there were no real injuries in fact--particularized as they need to be--to any of our children plaintiffs whom I represent here in front of you. You see, because there is no standing there is not actual case. And because there is no actual case this isn't really a closing argument in a jury trial. As a result, none of those testimonies of witnesses that you just heard and were impressed by actually happened.

We, my colleagues sitting here at the plaintiff's table and I, just managed to plant those happenings in your mind through a clever process of collective hypnosis.

Instead, ...”

Judge: “Counsel, it is now 4:25 pm, and this jury has been up in this courtroom since 8:30 am this morning, for the fiftieth day of jury duty in a row. I think this is a good time to take a break. Let's reconvene tomorrow morning with the continuation of closing statement. Alright? Any objections from anyone?”

Cutting Grass and Weeds

Seems like at this time of year the weeds start taking over. While the vast majority of properties in our neighborhood are well-maintained, there are always some who don't seem to mow as often as they should. And our many alleys often seem to get overgrown with volunteer vegetation.

The Omaha City Ordinance reads, in part:

It shall be the duty... to cut and clear such lot or ground, together with one-half of the streets and alleys abutting thereon, of all weeds, grass, and worthless vegetation which have reached a height of 12 inches or more. Such weeds, grass and worthless vegetation shall be cut as close to the ground level as possible and shall be maintained so that at any time the same does not extend 12 inches or more above the ground. Please note that properties that abut an alley are required to trim vegetation along the alley. Your cooperation is much appreciated.

Community Bike Shop News

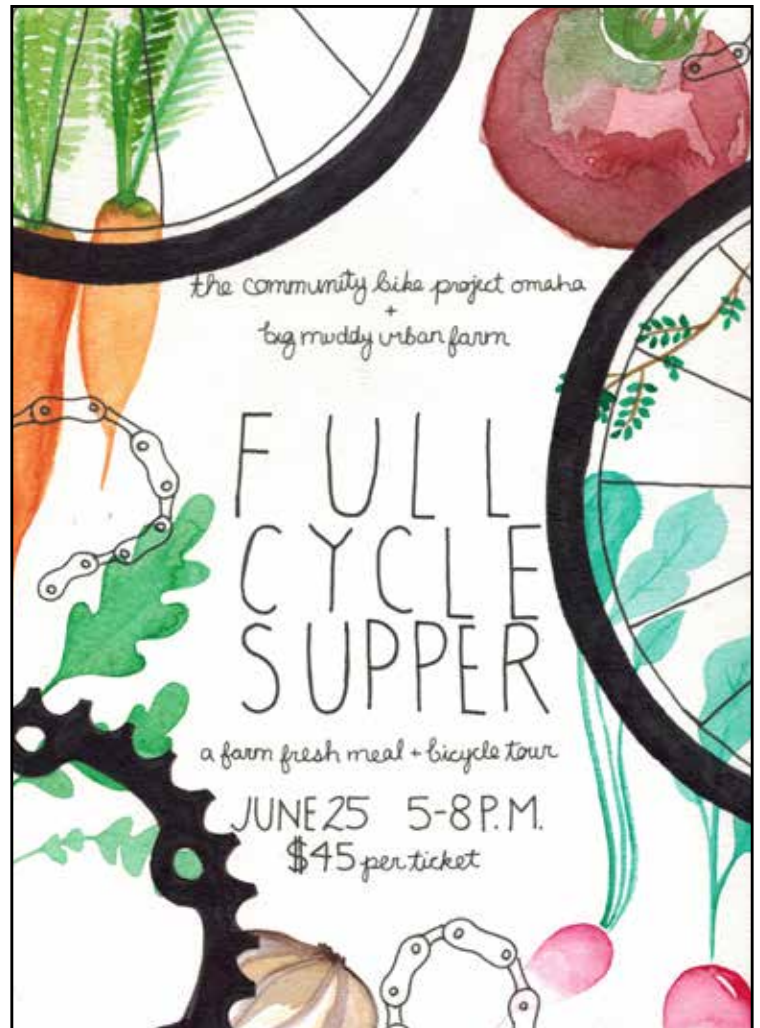
