First of all, the GPNA has been very involved in the discussions about the new elementary school: the ‘Ed. Spec.’ committee was set up with representatives of our neighborhood and met multiple times with OPS to share their vision and wishes. The result of these discussions will soon be visible, as OPS broke ground just before the summer, and the new elementary school is now a reality! But it is not over yet, and we will make sure to remain involved in future discussions and keep you updated about the progress.

Speaking about the GPNA involvement in new developments in the neighborhood, Eric Purcell, Andy Wessel and Chris Foster wrote the ‘Development and Property Management Code of Conduct’. The Let's Grow Here Gala was one of those times for celebration. Big Muddy is closing a successful first year of new programming and growth. Eliza jumped right into volunteerism, she is beginning her third year on the Gifford Park Neighborhood (GPNA) board, serving as secretary and membership chairperson for the past two years and nominated for president starting 2018. If you have been down to 33rd & California on any summer Friday evening, you would have seen Eliza in her stride managing the Gifford Park Neighborhood Market.

She is usually juggling lots of tasks, like helping setup tents and tables, meeting/greeting vendors and customers, playing with neighborhood children, and making sure everyone is having a great experience. As part of the Market, Eliza has been heavily involved with the third annual 33rd Friday Block Party & Yates Cultural event in August. At the last market evening in late September, Eliza helped organize Porchfest, a family-friendly, walking oriented festival making music on neighborhood porches - the first ever in Omaha. Porchfest was a huge success with plans to do it again next year. As you can tell, Eliza has a positive “roll-up-your-sleeves” attitude!

Eliza’s volunteer work and community building includes other important projects. She was instrumental the past 3 years on the “Save Yates” campaign to save Yates Community Center from being demolished by Omaha Public Schools (OPS), and to work on getting a new neighborhood elementary school. She continues to serve on our Educational Specification committee working with OPS on the school design. Eliza also volunteers with Big Muddy Urban Farm, neighborhood and park cleanups, community garden and youth garden programs, GPNA holiday banquet, Tour de Garden (annual bicycle tour of community gardens), the “Welcome” yard sign campaign, updates our GPNA Facebook page, and has written numerous and successful grants for GPNA. 

The Trial of the Century - Remembering About the Future 2037 - Part IV

I ask you to contrast that argument with the wise words of President Abraham Lincoln.

“A child is a person who is going to carry on what you have started.

This child is going to sit where you are sitting and, when you are gone, attend to those things which you think are important.

You may adopt all the policies you please, but how they are carried out depends on this child.

This child will assume control of your cities, states and nations.

This child is going to move in and take over your churches, schools, universities and corporations. The fate of humanity is in the hands of this child.”

I ask you to find that the children of Gifford Park neighborhood, many of whom you heard from or about these few

months, took on upon themselves the task of leadership even when it was not offered to them—as much as they could reasonably expect—by elected public officials. I ask you to find that under mentoring and guidance from the community, parents, community leaders, volunteers, and private donors, simply put just involved citizenry, Gifford Park compensated for the negligent ignorance that defendants allowed.

We ask you to realize who is not here today in the defendants' stand. No OPS board member, no city council member for this neighborhood, and no state senator was called as defendant in this trial. The neighborhood of the children I represent here in front of you has generally been quite happy with their representation over the years. They all passed on the concerns and requests to their respective bodies and tried hard to make strong arguments over and over again for those little things that were asked of the government bodies in question. They stayed engaged and always available to community meetings and gatherings, whether for work, fun or play. They gave their time and their attention, but they could only do so much. Could much more have been done? Of course. The bodies in question still didn't budge, or not enough most of the time. Private donors stepped up when they saw the movie that Mr. Brent Lubbert and Mr. Eric Purcell and others posted online to get a viral following of one million viewers, and when Ms. Eliza Perry, Mr. Martin Janousek, Mr. Chris Foster and many others went asking donors with dirt hill removal budget and new soccer field and Turner Park North youth sports park design in hand.

We ask that you don't allow the same to happen for the next forty years from this moment on. Yes, injury in fact happened. How much more could these children have achieved if they have been supported over the last forty years not just by the neighborhood, but by those called to support them as well—school district, city, state, and federal government? By those who keep promising that they care in every election over and over again tens of elections in a row? All while the dirt hill stayed on top of the soccer field for decades with nobody caring about all the missed potential buried underneath. All while more and more asphalt was taking over gardens and trees. While more children were missing out on the opportunity to learn urban farming and to become internationally renowned in the now classic field of slow food economics.

Traditionally, the US justice system affords monetary rewards as remedies in civil law suits. It has been a tradition by policy that a monetary reward should be sufficient to make plaintiffs whole. Our children of today, who are now young and wouldn't care for money, along with the children of the future, as Lincoln was alluding to in the quote I read you, don't care that much for money. Their parents showed everyone resilience and initiative and the strength of community ties and creative solution seeking and implementation. We think we all owe them a duty to fix forty years of their calls out for help and support being mostly ignored. We owe them more than just money. We owe them a change in culture that wouldn't allow this to happen anymore. We thus ask you, ladies and gentleman of the jury, to rule for us three ways:

1. to allow the new tort of negligent ignorance of citizens' delegated duty to proceed as the new law. This is certainly in the spirit of this Court granting in 1879 to Standing Bear the fundamental right of being a person under the Constitution of the United States.
2. to grant us the relief we ask for under the traditional tort of negligence, and under the new tort I just mentioned. Under the negligence tort we are quite modest. Once again, we just ask for half the money that was spent to move the dirt hill—the part that was not private donor funded and was spent by way of “child labor” actually moving the dirt hill with children sweat. The now parents will use that for improving the neighborhood further for all their children to benefit down the road for the next forty years. That's \$500,000

between all four defendants. Under the new tort of negligent ignorance of duty delegated by citizenry we ask for the compensation of the lack of all the needed improvements that didn't happen over the last twenty years. The required more asphalt overriding need for green every time. The budget and city code constraints limiting school garden or active kitchen, or accessible sports field--summer or winter alike. The impossibility to come to an actionable agreement on dual language in the new school. The lack of showcasing green energy production or usage, or urban farming activities and teaching children at school what the community was already teaching them on weekends at the community garden. The years it took before the community simply got fed up and, together with NuStyle development--who were also supporting the community initiatives on behalf of their residents, as you heard from their representative--, managed to stop over-expansion of parking and managed to shift the tide towards green over parking spaces in sync with the parents of our plaintiffs. As we have shown, all of these injuries over twenty plus years amount to much more than what we asked for—another \$500,000 between all four defendants.

3. to grant us fast-track licensing rights as part of this verdict to make possible the construction of the Gifford Park neighborhood Swimming Pool with part of the money awarded here. Children don't really care for money. They wanted a pool for a long time. The GPNA offered many alternatives, from the water slides to small wading portable above ground small inflatable pools in the summer. But a pool is a pool. You've seen how well return on community investment pays off in this neighborhood—nationally and internationally reputed athletes in every field, scientific pioneers, new fields of study. You name and it started in this neighborhood.

The future Michael Phelps of Gifford Park needs this pool. We know he's here. It shall cost no more than \$500,000 for a feasibility study, the design, and the building of a full amenities 75' x 36' pool within the Gifford Park, one with a small pool house, a separate wading area, a young children low water level area, and tables with retractable umbrellas for shade. The other \$500,000 shall be kept half for maintenance and staffing over the first twenty years, and the other half for other community improvement projects.

Money does not correct everything, but we are so used to this system for so long. These three things we ask for today would help compensate a little bit into the future what was not made available to the children by negligent governance for forty years.

Ladies and gentlemen of the jury,

The children I represent need your support and understanding, so that what happened to their parents doesn't happen to them too. So that other children elsewhere also expect a stronger duty towards their future from their own elected representatives. Give us your verdict. Thank you.
