BYLAW AMENDMENT

ARTICLE 5, SECTION C

Article 5, Section C of the Gifford Park Neighborhood Association Bylaws was amended as follows by a 13 to 9 vote at the August 3 meeting:

PREVIOUS FORM: This Association may support candidates and issues that would serve our objects and basic policies.

AMENDED FORM: This Association may support candidates and issues that would serve objects and basic policies when agreed to by 80% of members present and voting.

RATIONALE: To clarify voting procedure.

!!Gifford Park Improvements!!

If you haven't ventured to Gifford Park in awhile, you should be pleasantly surprised at the much needed improvements that have been made! The east bank of the park (by baseball diamond) has been cleared out, graded, and seeded. We also have 2 concrete slabs poured, 2 new barbeque grills, and 2 new picnic tables. Trees have been trimmed and the backstop has been repaired. We appreciate the attention from the Parks and Recreation Department!

It has been brought to our attention that some of the playground equipment is old and in disrepair (and potentially dangerous). We have notified Parks and Recreation of the situation. Hopefully, we can start the process of requesting purchase of new equipment. We have also been advised by the City that the official park sign for Gifford Park is in the 1990 budget. We would like to remind everyone that consumption of alcoholic beverages in city parks is illegal. If you witness this activity call 911.

Watts Trucking Service

It has been mentioned at a number of the monthly meetings that there is some confusion on what guidelines Watts Trucking Service uses concerning garbage pick-up. Watts Trucking Service has prepared the following guidelines for ALL OMAHA CITY RESIDENTS.

COLLECTION:

- * All refuse must be placed at the curb or alley by 6:00 a.m. on collection day.
- * During weeks with a holiday, collection for that week will be delayed one day for those residents whose collection day falls on or after the holiday.
- Refuse must be in a visible location with easy, unobstructed access.
- * Refuse for residential units up to and including 4plex apartments must be visible and located within 5 ft. of the curb or approved alley.
- Refuse for commercial establishments and 5-plex or larger apartments must be visible - at a single location within 20 ft. of the collection vehicle, with a 4 ft. wide unobstructed walk-way.

CONTAINERS:

- Each residential unit or business is allowed 8 Containers should be garbage cans per week. galvanized metal or rigid plastic.
- All containers must have tight fitting covers and sturdy handles, minimum 10 gallons, maximum 32 gallons, 75 lbs. total weight when full.
- Plastic bags are for leaves and lawn trimmings only. Bags must be securely tied, minimum 20 gallons, maximum 35 gallons, not exceeding 30 lbs when full.

Prohibited materials include industrial waste, sewage, rocks, concrete, dirt, manure, building (re-modeling-construction-demolition), in containers, explosive materials, liquids flammable liquids, dead animals, car parts, or items too large to be placed in a garbage can.
