WINTER REMINDERS FOR SNOW REMOVAL

Emergency Snow Routes are marked with signs. In our boundaries the following streets are Emergency Snow Routes:

Dodge Cuming

30th St.

When the Mayor declares a "Snow Emergency" parking will be banned on these routes. These bans are announced through radio and television stations (they will also

advise when the Snow Emergency is over). Cars parked or stalled on these routes will be subject to a fine and may be towed at the owner's expense. If you have a question please call the Public Works Street Maintenance Office at 444-4919 (24-hour street maintenance line).

Residential streets are usually plowed within 24 hours after the storm ends. Depending on the severity of the snowstorm (blizzard) it may take longer to clear all streets.

Although alleys are not part of the City's snow removal plan, crews will try to clean alleys on a complaint basis. However, this is not always possible because some alleys are too narrow for snowplows. The residents adjacent to the alley are encouraged to clear the snow from alleys immediately following a storm for best results.

Omaha's Municipal Code requires all sidewalks to be shoveled within 24 hours after a snowstorm. If left unshoveled, City crews may clear them at the property owner's expense.

It is also against City law to shovel show off private property into an alley or street.
