During the second week in July, a group of GPNA members and other residents of our community informally gathered to walk through various streets in our neighborhood at night, and watch the activities that occur after most of us are asleep. Ιt has been enlightening experience to say the least. Every Friday and Saturday night since then, this group has assembled and walked throughout the neighborhood, fine tuning our approach to where we now feel we for viable tool betterment of our community.

At the August meeting of the Gifford Park Neighborhood Association motions were put forward requesting that the Association sponsor this group and it's activities, and that this project be the subject of an application by the GPNA for a small grant from the Peter Kiewit Foundation. Both motions were voted upon and approved by the membership.

Since that time, the group has been named the GPNA Neighborhood Watch Group, and a set of operating procedures as well as a Code of Conduct for members have been established. With the approval of the GPNA Executive Board, three 2-way radios have been purchased with Association funds for use by the Group. From the original group of walkers, an experienced core of committed team members developed, that, although small in numbers, have proven effectiveness on several occasions. I am proud to be a member of this group, and I encourage anyone who truly wants to do something for our community to join us on our walks.

Our motive is simple, we walk and watch to enhance the safety of our community and it's residents. The Neighborhood Watch Group is non-confrontational, proactive, and we don't spy on anyone.

We walk and watch - if we observe laws being broken, we call the police. We also, by our presence, hope to send the message that the responsible, law-abiding residents of our community will not willingly tolerate the use of our neighborhood for drug-dealing, drunken parties or other types of undesirable behavior. Membership in this group requires self-discipline, the ability to conform to rules, the commitment of minimum of four hours volunteer time per month, and a true desire to be of service to our community. IF YOU CANNOT LIVE UP TO THESE STANDARDS, THIS GROUP IS NOT FOR YOU! If, however, you ARE interested in joining us, please call me at 341-4722 or Ron Yates at 558-6027. We will be happy answer your questions and/or schedule your participation in one our up-coming walks. schedule is limited at the present time, but as we increase numbers, we will expand, so please, if you think you'd like to take part, call us. To obtain maximum effectiveness. we need walkers.

We would also appreciate your cooperation in identifying problem areas in our neighborhood that should be included in our walk routes. If you see or hear of any continuing activity that is unlawful or disruptive, call us, and we will investigate the possibility of including your block on our route.

LEGISLATIVE REPORT

This fall, voters will be asked for their approval for several constitutional changes. In the coming months, I will focus on these proposals, this month taking a close look at two of the ballot issues.

Proposition 2 would empower the Legislature to establish an intermediate Court of Appeals below the Supreme Court. Nebraska's current judicial structure has had temporary court of appeals to deal with the backlog of cases awaiting review. This backlog is a result of more complex laws, a greater litigation incidence of increase in criminal prosecutions. Proposition 2 would maintain the right to an appeal to the Supreme Court for murder cases and cases of constitutional interpretation. by Legislature would determine. statute, the avenues of appeal for other court cases. As a member of the Judiciary Committee, I heard much testimony regarding the backlog of cases - a backlog that can delay judicial decisions for up to two years, causing injurious delays for hundreds of persons affected by those cases. That testimony convinced me that some action needs to be taken. I supported the 37-4 vote to place the measure on the fall ballot for voter approval.

A second measure, Proposition 4, would strengthen the Post-Secondary Coordinating Commission. This Commission would be given greater authority in coordinating programs, curricula and planning for the state colleges and universities. I had the opportunity to serve on the 1989 study commission that conducted an extensive examination of the governance of Nebraska's state colleges and universities. Proposition 4 is, I feel, a positive step in correcting some of the disjoint planning that presently occurs. As such, I also supported putting this constitutional measure on the ballot.
