
CHRISTMAS DECORATING CONTEST by Judi Caban

CHAIRMAN'S SUMMARY OF 1990 GPNA PRIORITIES

At the end of 1989, the GPNA was focused on these priorities:

- 1. Newsletter and information to the community -- Twelve newsletters were published; six mailed to members only, and six walked around to everyone in the community. Anyone may submit articles for the newsletter on any subject. The editorial page is open to all for opinions.
- 2. Revitalization of 33rd and California business district -- Although there are little visible signs of positive change, much work and effort has been put forward by the Association. Board members have met weekly with representatives from St. Joseph's Hospital, Creighton University, Boystown National Research Hospital, Omaha Public Schools, and others, in an effort to solicit their cooperation as neighbors. The fruit of this should be visible in 1991.
- 3. Additional Neighborhood Watch participation -- At the close of 1990, there are only four certified Neighborhood Watch Groups in GPNA boundaries:
 - a. 34th Street, California to Webster
 - b. Davenport, 35th Ave. to 36th St.
 - c. 32nd Street, California to Cass and Cottage Grove
 - d. Burt Street, 33rd to 34th Streets, and 34th Street, Burt to Cuming.

Two of these groups participated in "National Night Out" in August. We should have more neighborhood participation in this program.

- 4. Master plan for Gifford Park improvements -- The Master Plan Committee effort is ongoing. This year should bring to the GPNA a plan from Parks and Recreation with the city's and committee's proposals for consideration of the neighborhood. The official sign for Gifford Park as promised in 1989 by PR and PP should be on 33rd Street, near Cass. If anyone sees the sign, will you please let me know
- 5. Enhanced housing code enforcement -- The Housing and Community Development Department appear to be understaffed in field inspectors and at times may be the victim of neighbor's disputes; thus their effectiveness is less than desirable to the neighborhoods that need their services. We have had, in 1990, about four buildings that were condemned for demolition by the city. Of these, two were removed by the city, and two were removed by the owners. Two-for-four not bad for our neighborhood. Most owners do care.
- 6. Strengthening neighborhood pride and awareness -- This is the last priority as listed, but perhaps this is the bottom line in the usefulness of neighborhood associations. Gifford Park neighbors should feel proud of our participation in:

 - . Gifford Park team and Jr. J team
 - . Show Wagon at Gifford Park
 - . City-wide Spring Cleanup
 - . Fall Neighborhood Association Cleanup
 - . Holiday Decorating Contest
 - . Easter egg hunt for neighborhood kids
 - . Neighborhood picnic
 - . Pumpkin Patch for neighborhood kids
 - . Garage Sale

- . Brush Up Nebraska
- . Neighborhood Walk Group Committee
- . Police Ride-Alongs in 1990
- . Survey Committee
- . Blood-Mobile at St. Joseph's Hospital
- . Neighborhood Watch Groups
- . Street Sweeping
- . Optimists Bicycle Rodeo in Gifford Park
- . Mayor's Neighborhood Partnership Award
- . GPNA Drug-Free Zone signs and stickers

We also should be proud of our corporate neighbor, St. Joseph's Hospital. Their contribution and participation in the Association is vital to our neighborhood.

Our pride extends to the Health Sciences, Facility Planning/Management, and Student Services Departments at Creighton University. Their participation is also critical to our neighborhood.

The construction of a Medical Building at 30th and Webster, and the parking facility at 32nd and Burt, are the result of cooperation between the neighborhood, a hospital, and a private educational institution. Hopefully, this project will have a ripple effect to the 33rd and California business district.

It is an honor to serve as chairman of this Association. Any suggestions, criticisms, or advice, are always welcome at any time. It would be impossible to do the things we do without the help of the great people in the Gifford Park Neighborhood.

HOME REPAIR ASSISTANCE PROGRAMS AVAILABLE

During 1991, the City of Omaha will offer a number of home repair programs designed to assist low and moderate income homeowners. These programs range from minor home repairs for elderly citizens to home improvement financing for major repair projects.

The Home Handyman Program, which operates citywide, assists lower income, elderly households by making minor home repairs such as replacing a broken window, repairing a leaky faucet, or adding a handrail to a stairway. A contribution from the homeowner is requested based upon ability to pay.

To qualify for the Home Handyman Program, the homeowner or spouse must be at least 60 years of age. For further information about this program, please contact Mr. Bill Boyd at 444-5271.

The Emergency Repair Program also operates throughout the City. This program assists very low income households with emergency repair problems

needing immediate action. To find out if you qualify, or to request emergency assistance, please call Mr. Leon Komar at 444-5489.

The Reinvestment Area Program provides financial assistance for home renovation projects. Under this program, Community development Block Grant Funds are used to reduce the size of a home improvement loan from a private lender. Although priority is given to the repair of housing code items, some general improvements are also allowed.

The Reinvestment Area Program is available to moderate-income households in an area generally east of 42nd Street. If you are planning a home repair project and need financial assistance, please contact Ms. Cathy Kaspar at 444-5153.

Home improvements and repairs add safety and comfort to your living environment and increase the value of your property. I encourage you to take advantage of the home repair programs that are available.
