By cooperating and showing consideration for others, we can improve the quality of life in our neighborhood and maintain property values. How we act impacts on the entire area. Don't be a klutz — be a good neighbor!


# Renaissance Center Dedicated excerpts from a World-Herald article in the April 22, 1991 Morning Edition

The building at 36th and Cuming Streets, once a medical facility, is now regarded by Salvation Army officials as a house of God.

Now dubbed the Renaissance Center, the building was dedicated Sunday in a ceremony that marked completion of yearlong effort to bring to Omaha the largest of the Army's American social-services facilities.

- .... The new space allows for expansion in these social programs:
- . The emergency homeless shelter, from  $40\ \text{to}\ 50$  beds.
  - . Living space for pregnant teens, from 20 to 30.
- . A program that houses mothers of infants while teaching them parenting skills, from a capacity of four to six.

New programs are also slated.

Did everyone who participated in the Gifford Park Neighborhood Spring Cleanup have the same feeling I had at the end of the day? The feeling of sore, achy bodies all over, but also a feeling of great pride for our many neighborhood volunteers who made this a real team effort on a less-than-ideal weather day to work. The cleanup started at 8 a.m. and finished about 5 p.m. Saturday, April 13th.

#### Here is a recap of the day's events:

-filled 9 dumpsters (20 cub. yds each) and 5 City trucks
-hauled 3 full flatbed truckloads and 2 other truckloads of trees
and brush to Fontenelle Park, where they were recycled
into free wood chips by the City of Omaha

-collected \$115 in recycled aluminum and scrap metal

 -hauled at least 15 appliances to an appliance recycling centersold memberships totalling \$31 and collected other monetary donations.

 -collected garage sale items that were given away to people in the neighborhood

-cleaned many of the street sewer drains that frequently get clogged with trash

 -helped countless neighbors haul trash away that would not be easily done without the Spring Clean-up and neighborhood volunteers

-chowed-down 200 hotdogs and lots of pop and chips at the picnic in Gifford Park

Distasteful as it is for me to speak negatively, it must be said because we as a community have to be honest with each other or we will cease to live in peace, harmony, and equality. I'm concerned about our rights. Yes, our human and civil rights are under attack right here in our own neighborhood. The right to life, liberty, and the pursuit of happiness is being trampled on 33rd Street, and it's time this abuse came to a stop. As a member of the GPNA Watch GRP I have witnessed harassment of citizens by street thugs who assume ownership of the public right of way, and have no respect for the elderly, women, or children, or for that matter, themselves. These predators bully the good people of this neighborhood with their foul insulting language, and threats. They think the laws of decency do not apply to them or that somehow, because they have no selfrespect, the rest of us must tolerate their abhorrent behavior. Many of our neighbors do put up with this violation of their rights. Why? Because they are afraid. Because bullies thrive on fear and apathy. Because the rest of us ignore the problem and would rather hide inside our cozy little homes and make believe this isn't happening. It's easy to do. So, if you avoid that area, no one will bother you. Today we surrender 33rd Street to these punks. What will they take tomorrow, our wallets, our cars, our children? It's a sad state of affairs when a mother walking her child home from school has to detour five blocks out of her way, to avoid being sexually harassed and terrorized by this mob of low life slugs who fester on 33rd Street. Unfortunately, the GPNA WATCH GRP can't be there 24 hours a day, every day of the week. We do what we can with what we have, and it isn't enough. It's apparent the landlords who allow this abomination to occur from their properties are as loathsome as the leaches they permit in their buildings. But before we point fingers of blame, let's take a look at what we are doing. We are as much to blame, because this is OUR neighborhood, and WE are the ones who need to stand against this threat, as a community, united, and determined to expel this infestation that is growing every day, and eventually will take over the entire area if we continue to sit by and let it happen.
