THE BULLY PULPIT by Mike Caban

Since the appearance of an editorial that I wrote for the Omaha World Herald Public Pulse, I have received many positive comments from people who read the piece. It was cut considerably, but the edited version more or less reflected the thoughts behind the longer, more in depth, and perhaps more controversial original article that I submitted.

For those who are curious, the editorial dealt with my reaction to comments made by Senator Ernie Chambers, and other public and community leaders who wasted no time in condemning and accusing the police of racism, when a group of Central High School students were video taped and arrested last month. My reaction to the accusations of racism, by Senator Chambers especially, came out of a frustration that I, and many other people of color in this city feel when we hear this catch word misused so often.

There is no doubt that racism lives and breathes and is well entrenched, not only in Omaha, but in the entire nation. That it still exists is not to be denied. That it is systemic is another issue altogether, and one that I refuse to accept. What concerns me is that some people of color, who hold leadership positions sometime contribute to hatred and mistrust, by faming the flame of prejudice with irresponsible statements that lack any foundation in truth. Like in the story of the boy who cried wolf, one day, when the wolf really threatens, I'm afraid that no one will pay any attention to the plea for help.

Of greater concern to me is that people in leadership positions have a unique responsibility to our children. As role models, they must craft their words and actions carefully. And when Senator Chambers uses his muscle to intimidate everyone from the mayor on down, he is teaching children that right and wrong are irrelevant. It's the bully who wins the battle. Well, since I was a skinny little Puertorican kid in the Bronx, I've been dealing with bullies. I discovered early on that bullies only win when their opponents lack courage and conviction.

Children need to know they will be held accountable when they misbehave. Senator Chambers (and others) virtually showed them how to evade accountability when they are caught. Just scream "RACISM!" It was wrong of him to do that, and he should be ashamed of himself for setting our children up for future failures if they take his advice. I think the mayor and everyone else who bowed to the pressure were wrong, because they proved that bullies win. Sometimes they do, but that doesn't make it right. And I'd rather go down fighting for what's right, than to stand by and watch while bullies destroy our children.
