Be A Good Neighbor

We all want to live in a pleasant and attractive neighborhood. The generally fine appearance of our area is a testimony to this fact. Two things contributing to unsightliness in any neighborhood are weeds and litter. City Ordinances covering these are being enforced. Being a good neighbor means being

considerate of the rights of others.

Will Rogers once said, when asked to describe his idea of freedom, "Well it certainly is not the right to do anything we want to do anytime we want to do it - any fool can tell you that won't work. Our freedom only extends to the point where it begins to infringe on the rights of others." People have the right to live where it is peaceful, pleasant, clean, and quiet. Let us, as good neighbors, reflect these rights. Each month we will synopsize a different city ordinance. The following briefly covers those regarding weeds and litter:

City Ordinance 26.04010 Weeds & Litter 18-21-18-22 Litter includes the following:

- 1. Trash, rubbish, refuse, garbage, paper, rags, wood, plaster, cement, brick, stone, building rubble, grass, leaves.
- 2. Any machine or machines, vehicles or vehicle parts thereof which have lost their identity, character, utility, or serviceability as such through deterioration, dismantling, or ravages of time, are inoperative or unable to perform their intended functions.

It shall be unlawful for the owner, agent, occupant or other person in possession, charge, or control of any lot or ground in the city, or portion thereof, to do either of the following:

- A. Permit, allow, or maintain any growth of noxious weeds, grass, or other worthless vegetation eighteen inches or more in height.
- B. Litter or cause to allow litter to be deposited thereon or remain thereon except in proper receptacles.

The ordinance further states the obligation of all property owners and occupants to cut the weeds and grass on lots, parkways, and 1/2 the alleys abutting their properties.

If not cut, the city may do so and levy costs against the property. The city can likewise remove litter and assess costs. In addition, fines of up to \$50.00 may also be charged.




WALKERS WANTED FOR WATCH GROUP

The GPNA Watch was started four years ago with this mission:



The other day I heard a lunch talk by Marty Shukert, who formerly was Omahas Planning Director. He talked about some of the disturbing trends in urban design. He mentioned that new developments and commercial properties are designed more for automobiles than for people. When people think of a pleasant neighborhood, they think of sidewalks and trees and neighborhood businesses. In contrast, many new neighborhoods and business districts are inaccessible and even dangerous to pedestrians. Oddly, many new residential developments have no diversity and encourage neighbors to be isolated.

So perhaps we are not as disadvantaged as we thought in Gifford Park. We certainly have a diverse population. There are

plenty of sidewalks and trees and it is not at all difficult to take a walk and meet your neighbors. We have greenspaces and an incredible variety in architecture, and the beginnings of a neighborhood business district.

The challenge is to see the real potential in our neighborhood. We dont want to be Regency and we dont want to be The Projects. As Mr. Shukert mentioned, we should want a neighborhood that is a good place to live for people from all kinds of backgrounds - A neighborhood for the people. We certainly have a good start.
