# **Neighborhood Crime Survey Results**

In October and November, 1992, the GPNA Watch Group conducted a neighborhood crime assessment survey using *The Record* from the Omaha World Herald. At that time where were 31 reported incidents of activity involving our community over a thirty day period.

During the same time period in 1993, there were 15 reported crimes in *The Record*.

During December, 1995, the crime survey was again conducted for a thirty day period. The survey showed that individuals residing within the GPNA boundaries were sentenced for violations ranging from driving with a suspended Driver's License to Trespassing. The total within the GPNA boundaries was 14 which also included 1 robbery, 2 burglaries and 1 auto theft.

The parameters of the December, 1995 survey were expanded to include areas surrounding Gifford Park. This expansion included a fifteen block radius from 34th and Cass Streets which is approximately the center of our boundaries. You will be surprised to know that one address, 1702 Nicholas, had 21 reported incidents. This is more than the entire Gifford Park area incurred. Another address, 2400 N. 34th Street, had 7 incidents. Overall the area surrounding Gifford Park had 109 incidents recorded.

This indicates that we do not live in a vacuum. The areas surrounding ours impact us. We must support our sister neighborhoods and any city-wide organizations that share our concerns.

#### **GPNA and Police Address Problems**



On January 17th, several GPNA members met with Lt. Don Thorsen of the Omaha Police Department. The purpose of the meeting was for us to review the needs of the association including the following items:

- Better and more consistent enforcement of all laws via regular active involvement vs reactive involvement of Officers in our area
- Do a weekly tour of the entire area to monitor level of compliance and daily alertness of police in the area to spot violations. Citations must be written immediately. Effect will be to establish a strong POLICE AWARENESS with our citizens.

# Historically Speaking... Wohlner's Grocery

A small "L" shaped grocery store just east of the pharmacy at 3225 California had the reputation of having the finest meat-market in Omaha. People came from all over town to shop at Wohlner's California Grocery. Actually, most people shopped by phone for a home delivery. Albert Wohlner, an immigrant from Poland, opened the store when he returned from service in the Navy in World War I. He began in the grocery business as early as age 14 and had been a partner with a cousin, Sam Frohm, before the war. The store at 33rd and California opened about 1921 and relocated to 52nd and Leavenworth in about 1940.

Albert was married in 1924, and he and his wife, Mollie, lived for a while in the Shirley apartments between 33rd and 34th and California. They had two daughters. One daughter, Phyllis, married Sidney Swartz who went into the grocery business with his father-in-law. Now the grandson of Albert Wohlner, Mike Swartz, owns and operates the Wohlner Grocery at 52nd & Leavenworth. Three generations of grocers and still going strong when nearly all other independently owned stores have closed. This says a lot about the quality of the groceries and the integrity of the owners.



Specifically, we discussed the following items:

- Parking front yard parking; blocking driveways; dead storage on streets (inoperative, unlicensed, long term); dead storage in yards (inoperative and unlicensed); parking without permits; parking in No Parking Zones.
- Loud Vehicle Control cars, trucks, cycles, without mufflers or defective systems; vehicles with boom boxes.
- Parties and loud music.
- Crack down on unlicensed vehicles opportunity to check Bill of Sale and insurance coverage plus any violations.

The meeting was very productive as we shared our concerns with Lt. Thorsen. He is committed to working with the GPNA in all of these areas. We all agreed that the nuisance factor of frequent ticketing of violators will result in compliance even if dismissed after repetitions. Again a greater respect for the Police and the Law will occur. In addition, convictions in most cases can be a moneymaker for the City or School coffers.

On January 16, Leo Wilwerding and Ron Yates compiled a list of 52 vehicle violations in our neighborhood alone. As last month's article by Ron Yates stated "...parking and other minor violations are a precursor to major felony crimes...". The reason we feel minor violations should be addressed is to slow or eliminate the escalation of crime in our area. A recent newspaper article talked about "Zero-Tolerance Policing" in Houston, Texas. Under zero tolerance, no infraction is too minor for police action - not public urination, not trespassing, not even double-parking. The goal of zero tolerance is really the same as community policing: fight neighborhood disorder at the lowest levels in hopes of heading off more serious crime before it occurs. Crime is down significantly in several major cities implementing this approach.

The Omaha Police Department and the GPNA have worked together to make our neighborhood safer for all, and with Lt. Don Thorsen's leadership, we feel this effort will be as strong as ever.

Mr. Ross, a former Realtor, law enforcement officer, and social worker approached Ms. James, a community volunteer, and home daycare provider, with the concept of starting a daycare center. The first site, at 615 N. 33rd Street, was opened on March 5, 1994. This commercial store front was previously owned by Carl and Sheila Orand and operated as The Arctic Circle. Business was very good and the daycare soon filled. A need for additional space was realized. Richard Smith, owner of 619 N. 33rd Street, a vacant house, agreed to a lease. In January of 1995, the second daycare was opened. This daycare is operated strictly as an infant center.


