New GPNA Logo Chosen



GPNA Welcomes College Students

We have a large number of university students living in the area who are returning for another year of school. The GPNA has been working with the city and police to improve the appearance and safety of our neighborhood. The goal of the GPNA is to improve the neighborhood and make it a better place for all residents, and we would ask our new student neighbors to become a part of this effort.

The largest part of being a good neighbor is consideration for others. First we ask students to be considerate in terms of noise, especially after 10:00 PM. Many families in our neighborhood have children or go to work early. Parties are another problem. Unfortunately, parties always seem to end up bigger and noisier than first planned, and the police have been more active in enforcing noise and underage drinking ordinances. Another difficult problem is parking. Our neighborhood has barely enough parking (like school), so you may not always be able to park directly in front of your residence. Please do not park on lawns, across sidewalks or on the wrong side of the street (facing traffic). Besides making the neighborhood look bad, all of these are parking violations. Also, do not litter and help us keep our neighborhood picked up. Many of us pick up trash that we did not leave and we ask that you would help us by doing the same.

Finally, consider coming to one of our meetings and perhaps joining our association. A \$5.00 yearly membership will get this newsletter delivered to you every month, and you will meet your neighbors and many other wonderful people during our activities such as the neighborhood clean-up (we can always use more help) and walks. We welcome the students for the upcoming year, and we hope that you will help us continue to make the Gifford Park neighborhood a better place to live.

Historically Speaking... The Eccentric Man on 32nd Ave.

The following story is related in B.F. Sylvester's book <u>The West Farnam Story</u>

At 120 North 32nd Avenue stood the five bedroom, five bath house of Sarah W. Horbach, widow of John A. She had built the house to make a home for her daughter, Mary F. Bourke, and her grandchildren, Sarah, Anna, and Pauline, after the death of their husband and father, Captain John C. Bourke of the United States Army and graduate of West Point, class of 1869. As an enlisted man of the Fifteenth Pennsylvania Cavalry in the War Between The States, he had won the Army (Congressional) Medal of Honor the first year it was authorized. This was for leading a charge at the Battle of Stone River, Tennessee, December 31, 1862, at the age of 16 years.

The Horbachs had come to Omaha in 1856 and first lived in a three room house on Thirteenth Street. Five years later, they went to Allegheny, Pennsylvania, for the birth of Mary. Returning, they crossed the frozen Missouri River on foot carrying the baby. Indians used to look in at the window of the Thirteenth Street house to see the white papoose, who was joined two years later by a brother, Paul W.

The Horbachs prospered in real estate and built a larger house at 1623 Douglas Street. As a widow, Mrs. Horbach sold it for \$52,000 to J. L. Brandeis & Sons, for their department store. When Mrs. Horbach died, the house on 32nd Avenue went to her son and daughter. The son, Paul, agreed to pay his sister and her girls \$40,000 if they would give him immediate possession, with contents. The offer was accepted and the Bourkes went to live in Washington, D.C.

Paul was a bachelor, described as handsome, attractive, and a cynic. Twice appointed to West Point, he said, "I don't think I'm going to like this place," and left each time. He went to a technical school where he was a brilliant student, and graduated as an electrical engineer, but worked only briefly. He is said to have developed some eccentricities, one of which annoyed tremendously the members of the Omaha Club, where he lived for a time. A frugal man, he used to bring in a sandwich from outside for his lunch, after which he would go to sleep on a couch in the reading room. When he became delinquent on his Club bill, the Club had the excuse they were waiting for to drop him from membership.

Horbach occupied two rooms of his house in the summer for a couple of years, but lived downtown in winter because the house was cold. He would not rent or sell the place. It is told that real estate agents would call up with, "We have a very nice family..." "No," he would interrupt, "I won't have riffraff in my house." The house stood empty for 30 years. Horbach died at age 83 (1946). While he had kept out the "riffraff," he was not successful against vandals, insects and other forces of decay. Item: Seven motheaten Oriental rugs had to be burned. The house no longer stands.

GPNA Member Receives Korean War Veteran Medal

Bob Hutton, long time member of the GPNA, has recently received a commemorative pin for Korean war veterans from the office of Congressman Lee Terry. Bob received the Korean Service Medal with 5 stars and now awaits the Republic of Korea War Service Medal in recognition of the 50th anniversary of the Korean War. This special medal was originally offered by the Republic of Korea in 1951, but at that time the U.S. military did not allow its members to wear medals issued by foreign governments.

A national program for belatedly honoring Korean war veterans from a half-century ago is now in place. At the time of the war, these servicemen did not receive much recognition when they returned to the States or came out of the service.

the neighborhood homes.









OPD'S Citizens Academy Taking Applications For Next Class

The Omaha Police Department's Citizens Academy started in March of 1998. It provides participants with an in-depth overview of the operations of the Omaha Police Department. Some of the topics covered are: Defensive Tactics, Firearms Safety, Officer Safety, Mounted Patrol, K-9 Patrol, Air Support (Helicopters), Chaplains Program, Metro Unit, and others. Each participant will have an opportunity to go on a "Ride-Along" with an on-duty officer, and to participate in other simulated police activities. Participants must attend at least seven of the eight sessions to obtain the "Certificate of Participation."

Participants <u>must submit an application</u> vowing they are at least 18 years of age, list their Social Security number, home telephone number, and current address. All applicants will receive a police background and criminal history check. Participant selection is based on review of past criminal and driving history, with individuals showing a propensity toward illegal activity being declined participation. The next class begins **Tuesday**, **September 26**, from 6 - 9 pm and runs for 9 weeks. The application deadline is **Friday**, **September 15**. 

Be A Good Neighbor - Obey Laws Concerning Dogs

The Omaha Police Department Community Resource Center receives numerous calls about dogs running loose, damaging property and barking. It's good to know what city ordinances Omaha has to control these situations.

Sec. 6-102. Running at large. It shall be unlawful for any person to allow or permit any dog which is owned, kept, or harbored by him to run or be at large in or upon the private premises of others or upon the streets, highways, and other public places of the city.

Sec. 6-103. Restraint. It shall be the duty of every owner in the city to keep his dog securely restrained by a chain or otherwise confined in or upon his premises in some enclosure.

Sec. 6-104. Dogs damaging property of others. Whenever complaint is made to the poundmaster that a dog, whether with or without a license tag, is at large and doing bodily injury, it shall be his duty to investigate such complaint. If upon such investigation it appears that there is reasonable cause for said complaint, it shall be the duty of the poundmaster to report all pertinent facts to the city prosecutor, who shall then undertake the proper disposition of the case. If the defendant is adjudged guilty of a violation of this section, the court may, in addition to the penalty provided for the violation of this Code, order such disposition or destruction of the offending dog as may seem reasonable and proper in the premises.

Sec. 6-107. Noisy Dogs. No person shall own, keep, harbor, maintain, or permit on any parcel of land or premises under his control any dog which by loud, continued, or frequent barking, howling, or yelping shall annoy or disturb the peace and comfort of the inhabitants of any neighborhood or interfere with any person or persons in the reasonable and comfortable enjoyment of life or property; provided, however, this section shall not apply to the animal shelter, veterinarians, and medical laboratories.
