Counting On Your Vote

I hear it all the time. "Why should *I* vote? It won't make any difference. Who cares anyway?" In 1998, only 36% of registered voters went to the polls to cast their ballots. It was the lowest voter turnout since 1942. That means two out of every three Americans, 115 million eligible voters, simply stayed home. Many people explain their failure to vote by saying, "None of the issues seem to affect me *personally*." That's not the case this election year.

First, we have one of the tightest presidential races on record. It is only a week before the election and the polls still show the candidates neck and neck. Their views on Social Security, foreign policy, education, Medicare, taxation, affirmative action, national defense, gun control and the environment will affect the direction America takes in the 21st century.

Then there are the U.S. Senate, U.S. Congress, and State Legislature positions along with judges and other elected officials. These candidates represent Nebraskans within the governmental system. The more we express our values and concerns through voting, the better our elected leaders will be able to represent us and ou rindividual needs. Finally there are the Initiatives and Amendments. These can change the way we view our rights and the rights of others. They affect the way we live day to day.

You can play an important role in strengthening the voice that you and your community have on these issues. No one else can cast your vote. If you don't vote, you are letting others decide the future of your neighborhood, your state, and your country. Talk with friends and family about the issues and candidate's positions. Read the newspaper, pick up a sample ballot at the library, or look over a Voters' Guide (both sample ballots and Voters' Guides will be available at the November general meeting). Become an informed participant. Voting is important to our families and our community, and it's something almost everyone can do. This year, let your voice be heard. On Election Day, I hope to see you at the polls!

City of Omaha Code Enforcement Violations Chapter 48: Minimum Dwelling Standards of Exterior Dwellings

Listed below are some city code violations for dwellings. Be a good neighbor and find out why dwellings are not being kept up to code. Landlords and homeowners are required by law to keep dwellings up to code.

Basement Entry: Missing handrails, deteriorated sidewalks Chimney: Missing mortar, broken or missing backplaster

Doors: Not weather tight, not rodent proof

Down spouts: Rusty, leaking, deteriorated, or missing

Drain/Grade: Fill dirt around foundation, fill low spots in grade

Eaves: Deteriorated, missing, peeling paint Egress/Sidewalk: Cracked, broken, or upheaved Exterior Wall: Peeling paint, missing siding Fence: Deteriorated wood, collapsing

Foundation: Missing mortar, broken, or missing backplaster

Gutters: Rusty, leaking, deteriorated, missing Junk Cars on Street: Subject to vehicle impound Junk Cars on Licensed Property: Zoning violation

Junk Cars on Unlicensed Property: Subject to vehicle impound

Porch: Deteriorated

Porch Steps: Deteriorated, worn, upheaved, or missing handrails

Retaining Wall: On public sidewalk or alley only – not between two properties

Roof: Deteriorated, leaking

Rubbish/Garbage: In yard, around property - Weeds & Litter violation

You Can Make A Difference

I don't spend as much time as I used to on neighborhood association activities. Most of the time I probably don't spend 5 hours a month. I know Chris and some of the other officers spend 2 or 3 times that much, and I appreciate it.

I moved back into this neighborhood 17 years ago. Since that time I've seen many threats to the well-being of the neighborhood. Drug dealing and other crimes are the obvious causes of people giving up hope and moving out. Routine nuisances like loud parties, loud vehicles, litter accumulating on property, property not being maintained or lawns not being mowed, and junk cars are less severe, but over the long term can be equally persuasive arguments for moving where things are better. Every time people who care about the neighborhood move out and are replaced by people who don't, the neighborhood deteriorates a little. Few of us want to live in a neighborhood where that's happening. Fortunately, I'd say that the neighborhood is a better place to live now than it was 17 years ago and I believe the Association is the primary reason.

I don't need to list all the great things the Association has done for the neighborhood. If you read the newsletter you already know. What you may not know is that the vast majority of the things are done by a core group of maybe two dozen or so people. In some ways it's a little sad that, out of the hundreds of people who live in the neighborhood, these few people repeatedly bear the burden.

It's easy to say that things are going well, or that you're busy and don't have time, or you don't know the people involved, or you're not a joiner, or you don't like someone who is already involved, or plenty of other excuses. It's easy to let someone else spend the time and do the work and be responsible for making things better. But it's a constant struggle for that core group to stay motivated and active with so little participation from the general membership, especially considering the many people who live in the neighborhood and enjoy the benefits of the Association and don't even join, much less get involved. If you are reading this, and you are not a member, clip the coupon on the back page and send it in along with your dues. If you are a member, but don't come to the meetings or get involved in the activities, carefully consider the benefits you derive from the activities of the Association. and think about getting involved. That core group is friendly, motivated, and glad to see new faces. You can make a difference by spending as little as 1 or 2 hours per month. If it helps, consider your time and dues an investment in your future and the future of your neighborhood. Wouldn't it be great to look back from 2010 and say the neighborhood is better then than it was back in 2000?







Top Ten Tips For Neighborhod Communication

Community Boards of San Francisco offers these 10 suggestions for managing conflict with neighbors, strangers, and friends:

- 1. Talk Directly. Direct conversation is much more effective that sending a letter, banging on the wall, throwing a rock, or complaining to everyone else.
- Choose a Good Time. Try to talk in a quiet place where you can both be comfortable and undisturbed for as
 long as the discussion takes. Don't approach the other person as he or she is leaving for work or after you've
 had a bad day.
- 3. Plan. Think about what you want to say. State clearly what the problem is and how it affects you.
- 4. Don't Blame or Name-Call. Antagonizing the other person only makes it harder for him or her to hear you.
- 5. **Give Information**. Don't judge or interpret the other person's behavior. Instead, give information about your own situation and feelings, and how the person's behavior affects you.
- 6. **Listen.** Give the other person a chance to tell his or her side of the conflict completely. Relax and listen. Try to learn how the other person feels.
- 7. Show That You Are Listening. Although you may not agree with what is being said, tell the other person that you hear him or her and are glad that you are discussing the problem together.
- 8. Talk It All Through. Get all the issues and feelings out into the open. Don't leave out the part that seems too difficult to discuss.
- 9. Work on a Joint Solution. Two or more people cooperating are much more effective than one person telling another person to change. Be specific. "I will turn my music off at 10 p.m." is better than "I won't play loud music anymore."
- 10. Follow Through. Agree to check with each other at specific times to make sure that the agreement is still working.
