

Eva Swanson is GPNA'S "Neighbor Of The Year" for 2000

This year's "Neighbor of the Year" award went to our historian, Eva Swanson. Eva was recognized for her tremendous work uncovering all kinds of interesting people, places and stories right here in the Gifford Park neighborhood. Many people have enjoyed reading Eva's articles in our neighborhood newsletter for years. This fall she produced a wonderful book called History of 33rd & California and History of the GPNA, which is now available for a very reasonable price. Besides keeping our neighborhood's history alive, Eva has made many other contributions to the GPNA including cleanups, Easter egg hunts, Halloween haunted houses, newsletter, garage sales, neighborhood walks, picking up litter, and attending nearly every GPNA monthly meeting. She was recently featured in the Omaha World-Herald for presenting historical details about our neighborhood to a Neighborhood Builder's tour on Ollie the Trolley. Eva's parents Elmer and Elsa moved into the house where Eva currently lives in 1923 - the day they were married. In 1991, a former neighbor Rose Blumkin donated \$100 to the GPNA in honor of Elmer (who turned 100 years old) and his daughter Eva. We are grateful that the Swanson's chose the Gifford Park neighborhood to live in many years ago.

The President's Column

I hope everyone has made it safely through the holidays despite the rough weather in December. Of course the big event in December was our annual Holiday Banquet hosted for the twelfth year in a row by our great friends at St. Joseph's Hospital. It was nice seeing a great turnout of GPNA members and our honored guests who help us strive for a better community. We also had the neighborhood history books on hand at the banquet. Our historian **Eva Swanson** created the books. Come to the next meeting to buy a book at only \$6 for black & white and \$12 for color. There's more highlights about the banquet in this newsletter.

Unfortunately I have no news to report regarding the Chandler murder tragedy that happened November 12 at 521 N. 33rd St. The homicide unit at this time cannot give out information about the case or the mother's condition, since the case is still under investigation. The sargeant handling the investigation did ask that anyone with any information please call the **homicide unit (444-5656)** or **CrimeStoppers (444-STOP).** As mentioned in last month's newsletter, the GPNA donated \$100 to CrimeStoppers and \$100 to help the Chandler family. Crimestoppers will try to air another story about the case soon.

Police have given special attention to the 33rd & California area recently. It would not be appropriate to discuss specifics, but it has involved several different operations to reduce crime. Incidently, police have reported more problems at 521/523 N. 33rd St. in recent weeks. Also during the last week of December, police have focused on ticketing and removing dead storage vehicles in our neighborhood. Call the Mayor's Action Line (444-5555) to report these or other parking violations, because they can lead to serious safety issues for people trying to walk under tough winter conditions. The GPNA thanks Lt. Swircinski, Sgt. Osire and Sgt. Cook for their efforts in keeping our neighborhood a priority. Please keep in mind, in many cases the most effective way to prevent crime is for YOU to observe and report even minor violations.

I hope you plan to attend our next meeting as we will have a presentation by the Nebraska Lied Main Street Program. There is specific information about the program on page 1. This is a good time for our neighborhood to think about what we want our neighborhood to be in the short and long term. Overall I believe our neighborhood has done a pretty decent job of maintenance items like cleanups, code and parking violations, weeds & litter, watch group, tool lending, etc. — in fact we do as well as any neighborhood in the city. To have a stronger neighborhood and increase participation there has to be opportunities for people to want to get involved in many different areas. The Gifford Park neighborhood is one of the most diverse in the city — socially, ethnically, economically, agewise, culturally and housing-wise. These dynamics present the GPNA with tough challenges, but also great opportunities for growth. My hope is, at the very least, the process of learning about the Main Street Program will encourage people to become more involved with the GPNA and our neighborhood.

Snow Removal Information



A Snow Emergency means that no vehicles may be parked on the streets where you see an Emergency Snow Route sign. Crews will plow these streets first and the mayor will announce when the snow emergency is over. If cars are left parked on an Emergency Snow Route during a snow emergency, the cars will be subject to a fine and may be towed at the owner's expense. Radio and TV stations will broadcast all necessary information.

Omaha's Municipal Code requires all sidewalks to be shoveled within 24 hours after a snowstorm. Walks left unshoveled may be cleared by City crews at the expense of the property owner. Gifford Park's Pride is pleased to announce the addition of a new series of articles starting in this month's issue. Don Browers has written home repair articles for other neighborhood newsletters such as the Dundee – Memorial Park Association Newsletter, and he has graciously consented to let us begin running his articles in our newsletter. Don is very knowledgeable, and always provides interesting insights along with his repair tips. We certainly have plenty of older houses in our neighborhood, and we look forward to being able to run Don's articles when space allows.

"You need an old house mechanic," the old-timer wheezed. "Just a plumber or a carpenter or a painter or a whatever won't do. You need someone who can do a little bit of everything." In what was apparently a sustained period of insanity my wife and I decided that we really wanted to live in and restore an old house. We had only taken possession of our "Dundee Gem-In-The-Rough" as the real estate listing boasted and here we were knee deep in scavenged plumbing parts at an architectural salvage yard. The yard owner seemed more intent on dispensing advice than on selling old house parts. To be sure the point wasn't missed, he repeated s-l-o-w-l-y, "an old house mechanic."

So, that was the genesis of this column more than eight years ago. My modest goal is to share a few tips, some nuggets of information that may be helpful to the old house owner. And I try to cover the field - plumbing, painting, carpentry, you name it. Along the way we'll talk about old house living, sources for old house parts and services, and answer your questions. Please do use the contact information at the end of this column. This column is the most interesting and the most fun when it's interactive.

If you have any clever methods you've developed to restore your old house or just to cope with some of the maintenance headaches, this is a great place to share them. I'll also try to answer your questions about old house repair. If I don't have the answer, I'll find someone who does. I defer to the pros often, because I'm just like you, a do-it-yourself homeowner with no particular training in any of the building trades. I'll do my best to help you tackle projects yourself or to give you the background to better deal with the repair people you hire.

I'm really pleased that my column is now appearing here in the Gifford Park Neighborhood Association newsletter. (Look, Mom, I'm syndicated! I wonder if Dave Barry started out this way?) Omaha has so many great neighborhoods with unique old houses-Dundee, Ak-Sar-Ben, Benson, Field Club, Gifford Park, and more.

While this is not normally a cooking column, here's an old family recipe: Brass Hardware Stew. While this recipe won't do for a holiday dinner, it will get your tarnished, paint-spotted hinges, doorknobs, and other hardware shining brightly with a minimum of work.

After you've removed the hardware drop it into an old cooking pot. (I use an old enameled Dutch oven I picked up at a garage sale for 50 cents.) Cover the hardware with vinegar and place on the stove over a low heat for 15 to 30 minutes. Take out the hardware a piece at time and liberally shake on some ordinary table salt. Then rub with a fine grade (00 to 0000) steel wool. The tarnish and paint should easily wipe off. If it doesn't, let it stew a little longer in the hot vinegar.

Be careful not to get the vinegar so hot that you scald your hands and by all means wear sturdy rubber gloves. Also, don't let the hardware stay submerged in the vinegar overnight. Vinegar is an acid (although a very weak one) that will etch the soft brass and even permanently blacken it.

After the tarnish is gone, dry each piece of hardware with a cloth or paper towel. A quick application of a brass polish like Brasso and a swipe with a clean cloth and you'll have a very nice shine.





Naturally, if you've stewed your brass hardware, then there's only one thing left to do—bake it!

I apply a thin (I emphasize thin) coat of tung oil varnish applied with a clean, soft cloth. The results are even better if the finish is applied to the brass while it's warm. I set my oven to low heat—250 degrees—and then put the hardware in it on an old cookie sheet (another garage sale bargain). About 15 minutes of baking will do, again be careful—the brass should be warm, not hot to the touch. Then simply apply the tung oil with the cloth and let it dry overnight.

You can also coat the brass with clear lacquer from a spray can, but go easy. A light coat is all that is needed.

To finish off my list of old family recipes for brass hardware—did you know that Worcestershire sauce will work as a brass polish? It does a good job, but always leaves me hungry for a thick, juicy steak.



Christmas Tree Recycling Information

The City of Omaha Public Works Department - Environmental Quality Division is once again providing collection sites for Christmas tree recycling (the trees will be ground into mulch). Volunteers will be available at the sites from 10 a.m. to 4 p.m. on Jan. 6 & 7 for those who need assistance unloading trees. Please remove the following from the tree before bringing it to the collection site: nails, ornaments, plastic bags, wires, tree stands, and lights. Wreaths and evergreen roping, or wire-connected strands of evergreen will not be accepted. Flocked trees are acceptable. The following three sites closest to the Gifford Park area are:

> Ak-Sar-Ben (69th St. and Mercy Road entrance east of entrance gate)

Orchard Park (66th Street north of Hartman Avenue) Brown Park (U Street between 15th and 18th Streets)

The sites listed above will be open through January 12 - please do not deliver trees after this date. In addition, the City of Omaha Maintenance Facility at 11th and Locust Street will accept trees, but only from 10 a.m. to 4 p.m. on January 6 and 7.

Dead Storage Vehicle Ordinance

After a snowstorm, it's easy to see vehicles that haven't been moved for awhile. In the winter, this situation makes it difficult for snow plows to clean the streets properly. In any kind of weather, vehicles must be moved at least every 48 hours if they are parked on the street. If they are not moved, police can ticket and tow them to the impound lot. The cost to retrieve the vehicle from the impound lot is a minimum of \$75 plus \$15 each day the vehicle remains in the impound lot. Police have recently stepped up enforcement of this ordinance. Please be a consid-I erate neighbor and move your vehicle at least every 48 hours.
