## Proposed Assisted Living Center: The Facts As We Know Them

Many of you are aware of recent discussion regarding the proposed conversion of the Nebraska College of Business building located on the Duchesne Campus at 36th & California. The goal of the developers, California Housing L.L.C. (three Omaha individuals), would be to retrofit the property to accommodate 55 one-bedroom efficiency apartments to service the elderly. The developers say the projected need for senior facilities is very high over the next 15 years. The licensure for the facility would be for "Assisted Living" which accommodates seniors who are in need of some assistance with daily living such as supervision of medications and possible bathing. Housekeeping, meals, and utilities will be provided under the assisted living format. There will be a 24hour, 7-day a week nursing staff present in the building as well as an activities director, housekeeping, and dietary staff. All 55 units would be Medicaid eligible. Operations would be regulated by the State of Nebraska.

The developers will go before the Omaha Planning Board March 7 to request a "Conditional Use Permit" to operate an "Assisted Living" facility. They are asking for GPNA support for this project. The project developer and the project architect gave a presentation at our February general GPNA meeting. One of the developers and his attorney were invited to the February 15 GPNA board meeting to answer questions and concerns raised. They have also presented their plan to the Joslyn Castle Neighborhood Association. If the Planning Board approves the project, it would then go before the City Council for approval within a month or so of the Planning Board meeting. The developers said renovation could start as soon as July if the approval process goes well. Construction would take roughly six to eight months to complete.

It is anticipated that the cost of this project will be approximately \$3.5 million. Almost the entire building needs to be renovated, particularly the major mechanical systems, such as heating, cooling, and electrical. A new roof, windows, and elevators are needed. Sprinklers will have to be installed for fire safety and all of the plumbing facilities and ingress and egress hallways will have to comply with the American Disabilities Act (ADA). Duchesne plans to sell only the building and will maintain ownership of the land.

#### The President's Column

This winter season has obviously been one of the roughest weatherwise that we have experienced in a number of years, especially compared to the last few. Not only have we had above average snowfall and ice, but the extreme cold, particularly in December, is making this a winter to remember. With spring just around the corner, I for one would like to focus our thoughts toward the many activities and events of spring and summer. We certainly need everyone's help and ideas as we plan for our annual events including the Easter Egg Hunt in April, Tennis Blitz and Bike Rodeo in May, Neighborhood Cleanup and Sun Dawgs Youth program in June. We are excited to announce Gifford Park Day planned for May 5. These are all fun events most of which can involve the whole family. I'm sure additional activities will spring up too.

Besides the many good things nicer weather brings to our neighborhood, other activities come also. It's a great time for neighbors to get together to do fix-up projects, gardens, spring cleanup and just meeting in the park or on the street corner. Of course what we don't want to see is some of the criminal behavior that also seems to come with warmer weather. The GPNA met twice in February with police and other law enforcement officials at the Northeast Precinct to try to develop a strategy to reduce and prevent criminal activity before it gets out of control. We met with U.S. Attorney Tom Monaghan, Ann Camp with the U.S. Attorney's Office, JoAnne Singleton with Weed & Seed, Captain Pitmon Foxall, Lt. Swircinski, Sgt. Kathy Cook, Sgt. Adam Kyle with the Narcotics Unit, Sgt. Steve Osire, and other officers. I believe some progress was made, but it will take more work by everyone. It's no surprise that law enforcement resources seem inadequate for the amount of crime in our city, especially in the northeast precinct. The GPNA is asking everyone to participate in our neighborhood walks, which will begin soon with warmer weather. We plan to have them more frequently and do more walking in different parts of the neighborhood. Bring a friend or neighbor to help show support for our area. The GPNA is very committed to improving public safety in the Gifford Park neighborhood. We need your participation. These walks are probably the most effective thing you can do to show your support.

Besides the activities mentioned above, we have an interesting program for our March meeting. Police Chief Don Carey will be our guest speaker. With the upcoming primary (April 3) and general election (May 15) we thought it would be appropriate to give everyone a chance to meet the candidates for City Council District 3. Each candidate that attends will be given a couple of minutes to present their ideas and vision. The meeting will finish with discussion and a vote on the proposed Assisted Living Center (renovation of the Nebraska College of Business building on the Duchesne Campus at 36th & California). There has been much debate on this proposal. There is a lot more information about this matter in this newsletter.

In closing, I want to mention a few other items about our neighborhood that the GPNA is keeping an interest in. The GPNA has pursued the Main Street program (presented at the January meeting) in an effort to get training and network with other associations on revitalization efforts for our neighborhood. We have had a few discussions with Creighton University regarding their master plan and its impact on our neighborhood, but nothing solid at this point – we are in the process of scheduling a meeting with Creighton soon. The property manager of 521 & 523 N. 33<sup>rd</sup> Street indicated the property is for sale – any takers? And finally, recently on two separate occasions (at Neighborhood Builders and the Joslyn Castle Neighborhood Association meeting) Mayor Hal Daub talked about the idea of closing the underpass at 33<sup>rd</sup> & Cuming St. The GPNA has talked about this idea for years to help with public safety issues on 33<sup>rd</sup> & California. At this time I'm still trying to find out if this could happen.

As discussed at the February meeting, if the project is approved, the owners anticipate hiring a highly qualified professional management team. Once the management company is selected, the neighborhood associations will be immediately notified. There would be criteria for admittance and sustaining occupancy in this facility. That criteria would have a minimum age requirement to make certain the building is senior as well as a certain level of care to insure that there would not be undesirable profiles in the building. A representative of the GPNA and the Joslyn Castle Neighborhood Association would be welcome to visit with the management team and review the criteria to make certain that it is what everyone expects as a standard for this facility. The developers would be willing to make it a requirement of the "Conditional Use Permit" that this criteria will not change without notice being sent to the owners and anyone else who would like to be notified. Hopefully, this would provide a built-in check against the tenant profile deteriorating because of a changed definition of who may come in for services.

Any of the following individuals can be contacted if there are questions about this project: Dan Malone, president of Investment Property Resources, 334-5232; Jim Lang, the attorney for the project, 330-1900; Randy Meyer the architect on the project. 391-1823. Additionally, Dan Malone has invited anyone from our neighborhood or any other neighborhood that would like to meet at the St. Joseph Tower Apartments on the corner of 10th and Dorcas on Monday, March 5, 2001, from 6:30 to 7:30 p.m. Investment Property Resources was also the coordinating company for the conversion of this facility which was completed in December 2000. He will show the main common area of that converted building and also take questions in the chapel area from anyone who has not been able to attend any of the neighborhood association meetings and would like to have some additional information.

It is very important to become informed about this proposed "Assisted Living" Center. You are encouraged to visit the St. Joseph Tower Apartments on the corner of 10<sup>th</sup> & Dorcas and ask questions. You should ask yourself: Would this be a benefit to our neighborhood? Would it have no effect or would it have a negative impact? What are the long-term issues if the business fails? The GPNA Board will create a letter of support that will be voted on by GPNA members at our next GPNA meeting, March 1. This letter will include some specific criteria for our support. The vote will be for or against this letter of support. We plan to have copies of this letter and brief discussion on this matter at the meeting.

### ¿Se Habla Espanol?

When I called to set up the interview for this article, the woman on the other end of the telephone spoke in Spanish. This shouldn't have surprised me. After all, it was the *Consulado de Mexico* (Mexican Consulate), I was trying to reach. I was just unprepared to have "a little bit of Mexico" right here in Gifford Park. Fortunately for me, the woman was bilingual.

The Mexican Consulate, our newest neighbor, is located at 3552 Dodge Street. They have officially opened for business after several months of remodeling the former Bradley Flower Shop. Headed by Consulate Chief Jose Luis Cuevas and his staff of eight employees, they serve as a type of small embassy for Mexican nationals. This means people of Mexican descent now have a direct link to the Mexican government. They can visit the consulate to obtain official documents such as birth certificates, marriage licenses, or other identification information that may be on record in Mexico.

Americans wishing to visit Mexico can also benefit from the consulate's international connections. Various tourism requirements can be found out ahead of time so that documentation may be handled prior to the trip, ensuring a smoother visit. Business contacts can be made through the consulate staff to help area companies explore the possibility of working with Mexican companies.

"The hardest thing is getting the word out. (We want people to know) where we are and what we do," said Mr. Cuevas, sitting behind his desk in a freshly painted, newly furnished office. "We serve Nebraska, Iowa, North Dakota, and South Dakota. It's a large area. But we are slowly making (progress)." This is Mr. Cuevas' thirteenth assignment as a Mexican government official, so he was no stranger to the bureaucratic headaches he would encounter in establishing this consulate. There were questions concerning the location of the facility, various dealings back and forth with the Mexican and the US governments, requirements for a complete budget plan including furnishings and supplies, and finally changes in the administration in Mexico which would eventually call for a new budget altogether. "It is a lot of work and we are still working on it," Mr. Cuevas said.

The location was selected with an eye toward expansion. As you enter the building, you find yourself in a large waiting area filled with tables and chairs. The day I visited, there were 15-20 people in the lobby. The staff greets you from a long counter positioned midway through the building. Administrative offices follow behind the counter, in the rear of the establishment. Bits of Mexican décor are scattered throughout. There are plans to perhaps renovate the entire second floor into a Mexican cultural center. No doubt they will have room to accommodate the growing Mexican immigrant population of Omaha.

So if you, or someone you know, would like to experience "a little bit of Mexico" right here in the neighborhood, stop by the consulate Monday through Friday, 8am. to 1pm., and say "Hola".



It goes something like this: we become involved, accept responsibilities, influence others in the community, inspire some to become involved with us, and the cycle is then repeated. That is how a neighborhood stays strong.

Take a look at your commitment level. Where are you in the above-mentioned cycle? You can make a difference. Your neighborhood is what you make it.
