Destination Midtown Master Plan Near Completion

As most of you are aware the final DM (Destination Midtown) master plan document is planned for public release in April. The timeline set by the steering committee is aggressive but will ultimately help keep everyone focused on creating a solid vision and plan for the Midtown area. At our last DM steering committee meeting on January 22 we received the "Neighborhood Programs" draft copy for review. Neighborhood association representatives distributed copies of this 17-page document to their respective neighborhoods for review and feedback. Comments and recommendations will then be discussed by MNA (Midtown Neighborhood Association) to consolidate common issues — these will be forwarded to HDR (the project facilitator) to produce a revised document.

This same process will take place for the other key program drafts according to the following release schedule:

Transportation – February 5; Western Business Area February 26; Eastern Business Area – March 11; Parks and Open Space – March 25; Final review and release – April. Please contact Chris at 342-6006 or Ron at 344-0757 if you would like a copy of any of the above drafts to review and provide feedback; your input is needed.

The structure of the "Neighborhood Programs" draft document includes specific recommendations for the following areas: implementation mechanisms, public safety (including community policing), code enforcement, absentee landlords, rehabilitation of homes, buildings and small business districts (Main Street Program), zoning and overlay districts, maintenance and upkeep, historic preservation, parks, open space and community gardens, and neighborhood oriented mobility programs (including biking).

Of course implementing this plan will be challenging. This is why some of the DM steering committee members will be visiting Portland, Oregon to learn how this progressive city has implemented its master plan. Specifically regarding neighborhood issues, members of the steering committee will meet with city staff from Portland's Planning, Redevelopment and Community Development Corporation to see how they do


Free Tax Help Available Now

From The President . . .

We've received the initial report on the Destination Midtown study. The conclusion? The future of our neighborhood is in *our* hands. We already knew that, but it's nice to have some official recognition.

Well, they didn't come right out and say it, but when you read the fine print of the first draft, it talks about a lot of things that *ought* to happen, about funds that need to be raised—oh, did you catch that? When it comes right down to it, the resources *aren't* there—we have to find them.

We need to find the dollars and organize the priorities and set the agenda for our own neighborhood—and it's time to get started. I don't know about you, but I'm tired of waiting on others. We now have a roadmap that can serve as the template.

The next step is to initiate a Master Plan for the Gifford Park Neighborhood. Part of it has already started. The city planning department did a complete housing survey for Destination Midtown. In the past, the planning department came to Gifford Park and offered their help with a Master Plan. I think it is high time to take them up on their offer. We also need to challenge them on the code issues in our area.

We need to engage the police department in a discussion of "community policing." We have a new northeast precinct captain, Denise Cousin. She is a 20+ year veteran of the force and a second generation officer. I have invited her to speak to us at the next Gifford Park Meeting on Thursday. We look forward to meeting her and working with her on solutions.

We need to work with the City Council to provide incentives on old home rehabilitation. We need to find partners and investors who want to bring houses back to single home ownership and long-term stability. We need to apply pressure to absentee landlords and landlords who do not maintain their property or screen their renters. We are working on surveying rental properties and turning in those in noncompliance.

We need to be vigilant on our "green spaces." The state of Nebraska is due to dismantle the abandoned bridges at 30th and Davenport. We want to see these areas continue to be green and to become part of a "green corridor" between Turner Park, Bemis Park and Gifford Park.

Our business district is special. I would like our business owners and building owners to catch the vision of the future. The future of 33rd and California will be a bustling business district for all residents. There will not be drug dealing, fighting, intimidation or any other activity that detracts from the area. That is the future. Now we have to get there.

To do these things we have to be firm in our resolve, clear with our objectives and painstaking in our work. It is not a sprint, but a marathon. We have to find the right tools, the right partners and a huge long-term energy source to be successful—but I know we will. Would you be part of us? The Gifford Park Executive Board meets every third Thursday at 7:00 at Yates School. This is where we will be discussing and implementing these measures. You are welcome to join us—as a matter of fact, I'd be thrilled to see you!



Survey Reveals Members' Business Preferences

At the GPNA Holiday Banquet in December, those members in attendance were asked to complete a short survey about the types of businesses they would like to see in the Gifford Park "neighborhood of the future." The question that was posed was, "What stores or services would you financially support if they were offered in the local business district (33rd & California St. area)?" Ninety-three members responded to the survey question by choosing from 32 options. The top five vote-getters were:

- 1. Bakery
- 2. Coffee Shop
- 3. Deli
- 4. Bookstore
- 5. Ice Cream Shop

The results of the survey will be used in formulating the master plan for the neighborhood and in future business recruitment.

Own a Pet? Here Are 10 City Ordinances You Should Know About

- 1. Clean up after your pet: Sec. 6-74
 - It is unlawful for any person owning any animal to permit that animal to defecate on public property or any privately owned or occupied property without immediately cleaning or removing the excrement.
- 2. Don't let your pet be a nuisance: Sec 6-74
 - It is unlawful for your pet to engage in menacing behaviors such as chasing vehicles or frightening neighbors or passers-by
 - Don't permit habitual barking
 - Don't allow unsanitary conditions that would cause foul odors, attract flies or vermin, or otherwise threaten public health and safety
- 3. License your pet: Sec. 6-09
 - It is the duty of the owner of a dog or cat to ensure that the pet is licensed and bears an I.D. tag attached to a collar or harness worn at all times
- 4. Transporting pets in open trucks is illegal: Sec 6-86
 - Domestic animals are not allowed to be transported in an open cargo bed of a truck or the trunk of an automobile
- 5. Don't keep illegal animals: Sec. 6-81
 - It is unlawful for anyone to own any non-domestic animal including agricultural animals, animals that have reverted to a wild state, a wolf hybrid, or any other hybrid animals within the city
- 6. It is expensive when your animal is impounded: Sec. 6-50
 - 1st redemption is \$35, 2nd is \$70, 3rd is \$140
- 7. You must have a breeders permit in order sell or give away puppies/kittens: Sec. 6-143
 - Fee is \$100
 - Reimbursable if female is spayed within 3 months of litter
- 8. Special permits are required to own more than 4 dogs or 6 cats: Sec. 6-144
 - An inspection fee of \$100 is due at time of application for a Pet Avocation Permit, with an annual fee of \$50
- 9. Dog fighting is illegal: Sec. 6-85
 - It is also unlawful to knowingly and willingly witness dog fighting
- 10. Dangerous dogs must be: (Amended Sec. 6-152 6-157)
 - Spayed or neutered
 - Micro-chipped for identification
 - · Kept where warning signs are posted
 - Confined indoors or outdoors in an enclosed locked pen
 - Leashed and muzzled off-property
 - kept by an owner who must have a \$100,000 liability policy
