There are some specific short-term projects identified to take action on immediately, as well as long-term projects that will need significant planning and resources. 


Show Wagon Is Coming June 16

From The President . . .

As I was listening to this individual talking, my blood ran cold. He was in the neighborhood, talking about the residents and visitors of a problem property. He said, "Back in my day, the way we solved these problems was to get a few of us together and go over and pound 'em. But now they carry knives and guns, so ya' never know what you'll run into. What we need to do is take one and hang 'em up on that light pole. That'll get their attention!"

I hope that you are horrified by what you read! I certainly was, and I told him that I didn't appreciate that kind of talk. That kind of attitude is ignorant, prejudiced and racist. The conversation has bothered me ever since. When we talk about our neighborhood problems, how often do these attitudes seep into the conversation? Does our frustration lead to broad sweeping generalizations about ethnic groups and economic levels? Do we complain about "the poor" or "Section 8" housing?

I had another interesting conversation with a property owner who manages both upscale and lower income properties downtown. This person told me that the Section 8 tenants took better care of their apartments than the upscale! They had many more problems with upscale tenants trashing the place when they left. The key to the Section 8 success was the screening process. If your tenant history is bad, it informs the future when it comes to renting. So the problem isn't poor people, or a certain ethnic group. The problem is people who break the law, and the absentee rental property owners who shield them and allow them to operate without consequences.

That makes me think of two books my son read for English, A Tale of Two Cities, and Animal Farm. The stories are about the common people of France and Russia throwing off the oppression of the old aristocratic system. But in the act of "liberation" they overreacted and become tyrants themselves! They became no different than those they deposed.

Normally I try to be a cheerleader and have an encouraging column because I see much potential in our neighborhood. But I guess what I am saying is that we have to be careful not to lower ourselves to the level of those we are fighting against, who bring our neighborhood down by their illegal activities and intimidation.

On a neighborhood walk once, years ago, I got into a heated discussion with a neighbor who is no longer in the neighborhood. He, and someone else, were confronting a young black man who was on the corner about the clothes he was wearing. I told him that could be considered racist and that was not what our neighborhood was all about. Well, needless to say, he was not happy with me and defended it by saying, "You don't know what it is like to have "these people" saying horrible things to your wife!"

I do know what it is like, and I'm telling you, that kind of reaction is still not what this neighborhood is all about. We don't want to drop ourselves down to the lowest common denominator. We've talked before about how perception affects our neighborhood, but it can be skewed. I have to be careful about my perceptions as well. They can be formulated by prejudice. I'm a white male, who is reasonably trying to judge all things as fairly as possible. But why do I feel differently when I see two groups of teenagers? One group of white kids on skateboards in Dundee, I do not feel threatened by - they're "just kids." But when I see a gathering of black teenagers on 33rd & California, am I justified in

The Woodmen of the World recently presented Chris Foster with its Conservation Award for his efforts on behalf of the GPNA. In his address to the audience, he expressed his gratefulness to his friends in the GPNA and stated that he would proudly share the award with them. Chris was nominated by Cindy Smilley with Keep Omaha Beautiful and he wished to thank both her and Woodmen of the World for recognizing all of the GPNA members' efforts with cleanups, community garden, and other beautification projects.

Habitat for Humanity, in partnership with Mutual of Omaha and St. Cecilia's Cathedral is building a home at 708 N. 33rd St. on a lot that is currently vacant. A vast network of volunteers and donations keep Habitat building affordable homes in the community. Habitat was willing to arrive at a design for the house that would be compatible with the neighborhood, such as making it a one and a half story structure and including a porch with columns. Mutual of Omaha is a corporate sponsor through the volunteer efforts of its associates and its financial support of the orgainzation, and has made a significant monetary contribution toward the construction of this house. Plans are to have the house ready to occupy by September.



The Gifford Park Community Garden season opening event was held Saturday, May 1. Activities included a visit from the "Ask the Master Gardener" County Extention Office representative, garden & plant information, youth garden program registration, a visit from Dear Heart Clown (Judy Quest), free plants, seeds, & refreshments, and music provided by Clarinda Karpov. Cathedral Offers Free Arts Events

St. Cecilia's Cathedral is offering a variety of free cultural events this summer. Two organ concerts will be held at the church, located at 40th & Webster St.: Kimberly Marshall from Arizona State University will perform on Sunday, June 20 and Kevin Vogt and the Palladium Brass will perform on Sunday, July 18. Both concerts will be held at 3:00 p.m. A Spanish Colonial Art Collection is located in the ambulatory behind the altar; it is open between Sunday services and by appointment. The Cathedral Cultural Center located just east of the Cathedral will feature the art exhibit "Two Omaha Masters: Robert F. Gilder and J. Laurie Wallace" - thirty works by Omaha's leading artists of the early 20th century - from June 6 to July 25. Two lectures relating to these artists will also be presented: "Robert F. Gilder: His Life and Work" is scheduled for Sunday, June 6 from 1:30 to 3:30 p.m., and "J. Laurie Wallace and the Development of Art in Omaha" will be held on Sunday, July 18th, from 1:15 to 2:30 p.m. In addition to the art gallery, the Center features exhibits on the building of the Cathedral, including a section on nationally noted architect Thomas Kimball, who also designed Omaha's 1898 Trans-Mississippi Exposition and many other city landmarks. Hours are Tuesday through Friday: 11 a.m. to 4 p.m., and the 3rd Sunday monthly: 10:30 a.m. to 4:30 p.m. In addition to the free events. two antique appraisal sessions have been scheduled at the Center: Saturday, June 19, and Saturday, July 24, from 9 a.m. to 4 p.m. Verbal appraisals will cost \$6 for one item and \$10 for 2 items (limit 2). Written insurance appraisals will cost an additional \$15 per item. For more information on any of these events, call 551-4888.

assuming that nothing but trouble is happening? That is prejudicial thinking on my part, and something I have to guard against. I would encourage you also to not jump to conclusions.

Our neighborhood has always been diverse—ethnically and economically - I've said this before. Rose Blumpkin's family lived in this neighborhood as Russian Jewish immigrants. Our housing stock has both large and small homes. We've always had both poor and working class/ middle class. Diversity can be uncomfortable, but it has the opportunity to break down barriers. This is what we have that they don't have in the monochromatic, cookie cutter, suburban, west Omaha.

I would like our business district and park to bustle with people of all ethnic groups: white, Asian, black, Latino. It already does to a certain extent, because people of all ethnic groups and all economic brackets already live here. It's okay to feel uncomfortable, because crosscultural contact is always outside our comfort zone. My life has been enriched by the multicultural relationships I've developed. I challenge you to not stay where you are, but to hold your breath, jump in, and hold on for an exciting ride to the future! by Ron Frey
